Members,

Enclosed is an important letter from our Detroit Carpenters Pension Plan administrator, Benesys, that we are required to send to you regarding the status of the pension plan. Here are some facts and resources to help you understand this important correspondence, and how your union is taking steps to address challenges with the pension plan.

The Challenge We Face

The Great Recession hit Michigan harder than the rest of the country, impacting our union work hours, market returns, and the membership. We made sacrifices and tough decisions in 2013 to reform our pension plan and keep it out of the hands of the Pension Benefit Guarantee Corporation (PBGC). Had this fund been taken over by the PBGC, our members would have faced a drastic reduction in retirement benefits.

Since then, MRCC's membership has grown and work hours have increased, but our pension plan continues to face challenges. Our fund has enough resources to continue payments to retirees. But without a significant increase in membership and manhours, we will eventually start outspending our revenue.

Protecting and Preserving Our Pension

The MRCC is taking steps to preserve and protect our pension for retirees today and tomorrow.

First, we are working with outside financial experts to determine the best ways to stabilize and grow our pension plan. No matter what the financial experts suggest, any recommendations will be designed to protect and preserve the Detroit Carpenters Pension Plan.

Second, the actuary has determined that the single most effective way to grow this pension is by growing the membership and manhours. So we have launched an "all hands on deck" strategy to strengthen the long-term health of the pension by increasing our union's membership and work hours. It is important to keep growing our union to increase payments into our fund. The MRCC is already forming new partnerships with schools and businesses to grow our membership and increase union work hours. We are advertising to potential members, and much more.

Our union is made up of men and women who take action to solve the problems they are faced with every day, and each and every member can take steps to help us grow.

You can help us by:

- ✓ Reaching out to neighbors, friends and your church communities or gun clubs to attract young people to our profession.
- ✓ Mentoring and encouraging apprentices on the job and bringing them to union meetings.
- ✓ *Calling out cheating contractors* who pay people under the table. We need every dollar in our pension fund and you can help us recover it by calling **844-55-CHEAT** or **844-552-4328** to report contractors who break the rules.

The fact is, our pension still faces many challenges but the solution is in our own hands. In an effort to avoid making more difficult choices, you can help us with our "all hands on deck" strategy to grow our union and ensure it remains healthy in the future.

To: All Participants, Beneficiaries, Michigan Regional Council of Carpenters, Local Union, Contributing Employers and Employer Associations

Enclosed you will find two notices from the Carpenters Pension Trust Fund, both of which are required by law. Because they are technical in nature, the following summaries should help you evaluate them:

- 1. <u>2017 Pension Plan Status Notice</u>. As you were informed in previous years, the Pension Plan is required to conduct an annual study to compare the value of its assets to the benefits it will have to pay out in future years and to establish a funding ratio. If the resulting funding ratio is below the level set by law, the enclosed Notice of Pension Plan Status is required to be issued by the Pension Plan. This does not mean that the Pension Plan is currently unable to pay benefits, but only that it has to meet these new funding levels on an expedited basis. As evident from the enclosed notice, the funding level has not changed from last year it is still in the "red zone."
- 2. **2016 Annual Funding Notice**. This notice contains information regarding the Pension Plan's funded percentage, asset values, and investments. By law, the Annual Funding Notice is provided **after** the close of the Plan Year and relates to the 2015 Plan Year. In contrast, the Pension Plan Status Notice is provided approximately four months after the beginning of the Plan Year and relates to the current 2016 Plan Year.

Notice of Critical Status For Carpenters Pension Trust Fund - Detroit & Vicinity Pension Plan

This is to inform you that on July 28, 2017 the Plan Actuary certified to the U.S. Department of the Treasury and to the Plan Sponsor that the Plan is in critical status for the plan year beginning May 1, 2017. Federal law requires that you receive this notice. In the future you will receive an annual update of this status and the progress the Plan is making towards the goals described below.

Critical Status

The Plan is still considered to be in critical status because it is projected to satisfy the following:

<u>Projected accumulated funding deficiency within the current or next 3 plan years</u>

Note, "accumulated funding deficiency" means that contributions would be insufficient to satisfy Federal requirements; it does <u>not</u> mean that the Fund would become bankrupt or run out of money.

As required by law, the Plan Actuary's certification includes only contribution rate increases that have been codified in collective bargaining or participation agreements.

Rehabilitation Plan and Possibility of Reduction in Benefits

Federal law requires pension plans in critical status to adopt a rehabilitation plan aimed at restoring the financial health of the Plan. A rehabilitation plan may involve reductions to future benefit accruals, increases to contribution rates, or both. The law also permits pension plans to reduce, or even eliminate, benefits called "adjustable benefits" as part of a rehabilitation plan. The Plan offers the following adjustable benefits which may be reduced or eliminated as part of any rehabilitation plan the Pension Plan may adopt:

- Disability benefits;
- Early retirement benefits or subsidies;
- Benefits in effect less than 60 months;

Certain benefits were reduced pursuant to the rehabilitation plan, and you were mailed a notice of these reductions. If the Trustees of the Plan determine that additional benefit reductions are necessary, you will receive a separate notice in the future identifying and explaining the effect of those reductions. But you should know that whether or not the Plan reduces adjustable benefits, the Plan is not permitted to pay any lump sum benefits in excess of \$5,000 (or any other payment in excess of the monthly amount paid under a single life annuity) while it is in critical status.

Future Experience and Possible Adjustments

The rehabilitation plan is based on a number of assumptions about future experience and may need to be adjusted in the future if such assumptions are not met. Additional contribution rate increases and/or reductions in the rate at which benefits are earned may be needed if the Fund were to suffer asset returns below the expected 7.50% (in the 2017-18 plan year or later), a drop in the hours worked, or poor experience from other sources. If, at some point in time, the Trustees determine that further adjustments are necessary, you will receive a separate notice identifying and explaining the effect of those changes.

ANNUAL FUNDING NOTICE – ACTUARIAL INFORMATION

Carpenters' Pension Trust Fund Detroit and Vicinity Plan Year Beginning May 1, 2016

This notice includes important funding information about your pension plan (the "Plan"). It also includes general information about the benefit payments guaranteed by the Pension Benefit Guaranty Corporation ("PBGC"), a federal insurance agency. All traditional pension plans (called "defined benefit pension plans") must provide this notice regardless of their funding status. This notice does not mean that the Plan is terminating. It is provided for informational purposes and you are not required to respond in any way. This notice is required by federal law. This notice is for the plan year beginning May 1, 2016 and ending April 30, 2017 (referred to hereinafter as the "Plan Year").

How Well Funded Is Your Plan

The law requires the administrator of the Plan to tell you how well the Plan is funded, using a measure called the "funded percentage." The Plan divides its assets by its liabilities on the valuation date for the plan year to get this percentage. In general, the higher the percentage, the better funded the plan. The Plan's funded percentage for the Plan Year and each of the two preceding plan years is shown in the chart below. The chart also states the value of the Plan's assets and liabilities for the same period.

Year-End Fair Market Value of Assets

The asset values in the chart above are measured as of the Plan's valuation date. They also are "actuarial values." Actuarial values differ from market values in that they do not fluctuate daily based on changes in the stock market or other markets. Actuarial values smooth out those fluctuations and can allow for more predictable levels of future contributions. Despite the fluctuations, market values tend to show a clearer picture of a Plan's funded status at a given point in time. The asset values in the chart below are market values and are measured on the last day of the Plan Year. The chart also includes the year-end market value of the Plan's assets for the two preceding Plan Years.

Endangered, Critical or Critical and Declining Status

Under federal pension law, a plan generally is in "endangered" status if its funded percentage is less than 80 percent. A plan is in "critical" status if the funded percentage is less than 65 percent (other factors may also apply). A plan is in "critical and declining" status if it is in critical status and is projected to become insolvent (run out of money to pay benefits) within 15 years (or within 20 years if a special rule applies). If a pension plan enters endangered status, the trustees of the plan are required to adopt a funding improvement plan. Similarly, if a pension plan enters critical status or critical and declining status, the trustees of the plan are required to adopt a rehabilitation plan. Rehabilitation and funding improvement plans establish steps and benchmarks for pension

plans to improve their funding status over a specified period of time. The plan sponsor of a plan in critical and declining status may apply for approval to amend the plan to reduce current and future payment obligations to participants and beneficiaries.

The Plan was in "critical" status in the Plan Year ending April 30, 2017 because of a projected funding deficiency after recognizing amortization extensions within the current or nine succeeding plan years. In an effort to improve the Plan's funding situation, the Trustees adopted a rehabilitation plan on September 27, 2008. This rehabilitation plan includes the use of the "exhaustion of all reasonable measures" clause at IRC 432(e)(3)(A)(ii). Therefore, we interpret scheduled progress for the Plan to mean continuing to use all reasonable measures to forestall insolvency. Scheduled progress was satisfied because the annual consideration that all reasonable measures continue to be employed was undertaken in the past year.

Federal law requires the Board of Trustees to monitor the progress toward achieving the objectives and annual standards of the rehabilitation plan. The Board of Trustees remains committed to the proper funding of your pension benefits and assures you that they will take appropriate actions to meet this goal. The rehabilitation plan and its objectives and annual standards are based on a number of assumptions about future experience and may have to be adjusted if those assumptions are not met. Additional contribution rate increases and/or benefit reductions might be required. You will receive a separate notice identifying and explaining any additional changes in benefits, if necessary, and you will receive an annual notice, like this one, identifying any event that has a material effect on Plan assets or liabilities.

You may obtain a copy of the Plan's rehabilitation plan and the actuarial and financial data that demonstrate any action taken by the Plan toward fiscal improvement by contacting the plan administrator.

Participant Information

The total number of participants in the Plan as of the Plan's valuation date of May 1, 2016 was 19,031. Of this number, 5,246 were active participants, 7,290 were retired or separated from service and receiving benefits, and 6,495 were retired or separated from service and entitled to future benefits.

Funding & Investment Policies

Every pension plan must have a procedure to establish a funding policy for plan objectives. A funding policy relates to how much money is needed to pay promised benefits. The funding policy of the Plan is to maintain a level of benefits and contributions such that it will attain a healthy funded percentage for purposes of the Pension Protection Act by the end of the Rehabilitation Period.

Once money is contributed to the Plan, the money is invested by plan officials called fiduciaries. Specific investments are made in accordance with the Plan's investment policy. Generally speaking, an investment policy is a written statement that provides the fiduciaries who are responsible for plan investments with guidelines or general instructions concerning various types or categories of investment management decisions. The investment policy of the Plan seeks to prudently invest plan assets, consistent with the Trustees' fiduciary duties. Accordingly, assets of the Plan are actively managed so that investment decisions regarding particular securities or other investments to be purchased or sold are the result of a conscious exercise of discretion. The primary focus is on preservation of capital with emphasis placed on fixed income and equity broad market averages while markets are rising, and preservation of capital during market contraction.

The overall objective is to maximize long-range returns while maintaining a high standard of portfolio quality and a consistent return. The Plan relies upon the advice of professional investment managers to insure that this standard is met. The Plan's trustees have adopted the asset allocation targets outlined below to serve as a guide.

Right to Request a Copy of the Annual Report

Pension plans must file annual reports with the US Department of Labor. The report is called the "Form 5500." These reports contain financial and other information. You may obtain an electronic copy of your Plan's annual report by going to www.efast.dol.gov and using the search tool. Annual reports also are available from the US Department of Labor, Employee Benefits Security Administration's Public Disclosure Room at 200 Constitution Avenue, NW, Room N-1513, Washington, DC 20210, or by calling (202) 693-8673. Or you may obtain a copy of the Plan's annual report by making a written request to the plan administrator. Annual reports do not contain personal information, such as the amount of your accrued benefit. You may contact your plan administrator if you want information about your accrued benefits. Your plan administrator is identified below under "Where To Get More Information."

Summary of Rules Governing Insolvent Plans

Federal law has a number of special rules that apply to financially troubled multiemployer plans that become insolvent, either as ongoing plans or plans terminated by mass withdrawal. The plan administrator is required by law to include a summary of these rules in the annual funding notice. A plan is insolvent for a plan year if its available financial resources are not sufficient to pay benefits when due for that plan year. An insolvent plan must reduce benefit payments to the highest level that can be paid from the plan's available resources. If such resources are not enough to pay benefits at the level specified by law (see Benefit Payments Guaranteed by the PBGC, below), the plan must apply to the PBGC for financial assistance. The PBGC will loan the plan the amount necessary to pay benefits at the guaranteed level. Reduced benefits may be restored if the plan's financial condition improves.

A plan that becomes insolvent must provide prompt notice of its status to participants and beneficiaries, contributing employers, labor unions representing participants, and PBGC. In addition, participants and beneficiaries also must receive information regarding whether, and how, their benefits will be reduced or affected, including loss of a lump sum option.

Benefit Payments Guaranteed by the PBGC

The maximum benefit that the PBGC guarantees is set by law. Only benefits that you have earned a right to receive and that cannot be forfeited (called vested benefits) are guaranteed. There are separate insurance programs with different benefit guarantees and other provisions for single-employer plans and multiemployer plans. Your Plan is covered by PBGC's multiemployer program. Specifically, the PBGC guarantees a monthly benefit payment equal to 100 percent of the first \$11 of the Plan's monthly benefit accrual rate, plus 75 percent of the next \$33 of the accrual rate, times each year of credited service. The PBGC's maximum guarantee, therefore, is \$35.75 per month times a participant's years of credited service.

Example 1: If a participant with 10 years of credited service has an accrued monthly benefit of \$600, the accrual rate for purposes of determining the PBGC guarantee would be determined by dividing the monthly benefit by the participant's years of service (\$600/10), which equals \$60. The guaranteed amount for a \$60 monthly accrual rate is equal to the sum of \$11 plus \$24.75 (.75 x \$33), or \$35.75. Thus, the participant's guaranteed monthly benefit is \$357.50 (\$35.75 x 10).

Example 2: If the participant in Example 1 has an accrued monthly benefit of \$200, the accrual rate for purposes of determining the guarantee would be \$20 (or \$200/10). The guaranteed amount for a \$20 monthly accrual rate is equal to the sum of \$11 plus \$6.75 (.75 x \$9), or \$17.75. Thus, the participant's guaranteed monthly benefit would be \$177.50 (\$17.75 x 10).

The PBGC guarantees pension benefits payable at normal retirement age and some early retirement benefits. In addition, the PBGC guarantees qualified preretirement survivor benefits (which are preretirement death benefits payable to the surviving spouse of a participant who dies before starting to receive benefit payments). In calculating a person's monthly payment, the PBGC will disregard any benefit increases that were made under the plan within 60 months before the earlier of the plan's termination or insolvency (or benefits that were in effect for less than 60 months at the time of termination or insolvency). Similarly, the PBGC does not guarantee benefits above the normal retirement benefit, disability benefits not in pay status, or non-pension benefits, such as health insurance, life insurance, death benefits, vacation pay, or severance pay.
