#### Project Benefits

The purpose of this grant is for Choctaw Transit to address safety and security improvement and improved maintenance services. The Safety Committee met on the best way to address the issue of safety for our passengers as well as our transit drivers and to improve services for the maintenance program services of the 5311 fleets. It was determined that the communication towers used and the

current radios used were not providing a clear communication with dispatch and drivers because of the rural area services. The solution was to replace antiquated radios with digital radios. Further, to enhance services and safety for passenger and driver safety and security, surveillance cameras management system will be installed in 30 transit fleets.

**Additional Information**

The Mississippi Band of Choctaw Indians' Reservation is located in East Central Mississippi. The services includes the following counties: Neshoba, Winston, Kemper, Newton, and City of Meridian. The Choctaw Transit provides general public, worked-related commuter, non-emergency medical and elderly and disabled transportation services in the counties in which the Choctaw Indian Reservation is located. Choctaw Transit program has partnered with the City of Meridian to provide a transit services 5 days a week. Services are available to anyone(not just tribal members) living in the counties serviced by Choctaw Transit.
