On October 4th, the WIPS 20.0 release deployed to production.

This release included.

- Implementation of PIRL 2021 to support reporting for quarter 9/30/201 submission
- Upload improvements to concurrently support all 3 versions of the PIRL - PIRL 2018, PIRL 2020 & PIRL 2021
- Restricting NFJP and AP submissions to only allow reporting under the PIRL 2021 version
- Added and/or updated Logical Rules for existing data elements under PIRL 2021
- Updated the DINAP aggregations for Training Services
- Created a new interface to display NFJP Performance Targets and Enrollment Goals for NFJP CST and Housing grants under My Profile tab
- Updates to H-1B aggregations and cohort date ranges for Section E
- Implementation of Demonstration Grants QPR and availability of listed functionality starting quarter 9/30/2021 - demonstration schema for submission, demonstration report on interface and PDF, Quarterly Narrative Report.
