### NFJP Rollup report and data export

- The NFJP Rollup Report Export is a rollup single report and a excel export of all the certified report for 3 time periods and QNR.
- The Rollup reports display rollup data for selected quarter.
- The NFJP rollup report is displayed on the NFJP template.
- The NFJP rollup reports export is accessed Reports>National Reports>National Quarterly Discretionary Reports
- User makes selection for required quarter under Quarter End Date filter.
- User makes selection for NFJP Farmworker Jobs Program from the Program filter.
- Making selection in the filter Grant Type filter would display Housing grant rollup data OR Non-Housing on the interface.
- User clicks on Export Spreadsheet button to export the raw data.
- User should be able to download the excel file which has 4 sheets, 3 tabs for each period and QNR tab:
  - ♦ Quarterly
  - ♦ Rolling 4 Quarters
  - ♦ Program to Date
  - ♦ QNR
- The print pdf is available for rollup report.

- Updated Status filter on Dashboard and data download.

#### > Technical Assistance site

- Manage State National Dislocated Worker Grants is updated to remove the grants numbers from grid.
- User lands on Program Management TAB > NDWG State Program Management HYPERLINK > Manage State National Dislocated Worker Grants GRID
- User clicks on the EDIT button.
- Interface displays Edit section.

- The Edit section have new REMOVE GRANT button.
- User selects the grant number which needs to be permanently removed from the grid.
- User clicks on REMOVE GRANT button.
- Interface display warning message: Select Yes to remove Grant from the assigned state.
- Clicking on Yes, remove the selected grant number from state.
