New! Dislocated Worker Grant's (DWG) Quarterly Performance Report

We are excited to announce the implementation of DWG's program-specific QPR!

As a part of the roll out of program-specific QPRs for most of ETA's programs, WIPS release 14.0 includes a new National Dislocated Worker Grant (DWG) specific QPR template. This new format was approved through a non-material change to the DOL-only Information Collection Request (ICR) on 11/20/2019 (OMB control no. 1205-0521). Additional program-specific QPRs from this ICR will be released as they are programmed into WIPS.

Notable additions that the DWG QPR has that are different from the standard QPR include:

- Addition of a line on the QPR for disaster relief assistance to display the number of individuals in disaster relief assistance.
- New section of the DWG QPR called "Effectiveness in Serving Employers". This section adds the retention measure, as explained in TEGL 14-18, "Retention with the Same Employer in the 2nd and 4th quarter after exit."
- Primary indicators of performance will now calculate according to the guidance in TEGL 14-18, removing
