SUBJECT: Notice of Program Year (PY) 2013 Final Youth and Adult Allotments for WIA,

Section 166 Program.

1. <u>Purpose</u>. The purpose of this Training and Employment Guidance Letter (TEGL) is to provide final PY 2013 funding allotments, and to provide instructions for submitting the necessary documents to obtain these allotments for the Supplemental Youth Services Program (SYSP) and Comprehensive Services Program (CSP).

- **3.** <u>Background.</u> On March 26, 2013, the Consolidated and Further Continuing Appropriations Act, 2013, Pub. L. 113-6 (CCFCAA) was signed into law. Section 3004 of Division G of the CCFCAA incorporated a mandatory across the board rescission of 0.2 percent impacting all Federal Fiscal Year (FY) 2013 discretionary funding. The 0.2 percent rescission applies to the PY 2013 funding for the programs covered by this TEGL. Additionally, all FY 2013 discretionary program funding is subject to a 5.0 percent reduction under the sequestration order required by section 251A of the Balanced Budget and Emergency Deficit Control Act, as amended.
- **4. PY 2013 Section 166 Funding.** As a result of the 0.2 percent rescission and the 5.0 percent reduction, the PY 2013 INA appropriation levels are: \$11,720,629 for youth SYSP and \$45,082,291 for adult CSP. Under WIA, the Employment and Training Administration will reserve 1.0 percent of adult funds for Training and Technical Assistance purposes. For comparison, the PY 2012 appropriations were SYSP \$12,365,295 and CSP \$47,561,938.

The U. S. Department of Labor (DOL) Office of Grants Management will obligate PY 2013 grant funds through two separate WIA Section 166 grant modifications. The first official change will obligate the PY 2013 SYSP allotment through a unilateral modification to the current grant. The DOL Grants Office will issue the SYSP Notice of Obligation (NOO) by e-mail to the grantee's Authorized Representative and WIA Program Administrator/ Director. Grantees have 30 days from receipt of the NOO to submit the required documents (see Section 5, "Action Requested" below) by e-mail to their Federal Project Officer.

The second official change will obligate the PY 2013 CSP (adult) allotment through a unilateral modification to the current grant. PY 2013 CSP funds will be obligated on or around July 1, 2013. Grantees must submit a separate packet of required documents (described below, PDF format preferred) by e-mail to their FPO within 30 days from the date of this TEGL.

Note that a separate packet of documents must be submitted for the SYSP and CSP allotments. The Standard Form (SF) 424 and SF-424A are currently posted on the DINAP home page at http://www.doleta.gov/DINAP/cfml/wiaform.cfm, and on the INA Workforce3One website at https://ina.workforce3one.org/page/prog_planning. Grantees should retain the original signed SF-424 in their grant file.

- **5.** <u>Action Requested.</u> In accordance with SGA/DFA PY 11-07, grantees need to report the following by email, preferably in PDF format, for both the SYSP and CSP PY 2013 allotments:
 - a. An SF-424 "Application for Federal Assistance," which can be obtained at http://www.doleta.gov/dinap/pdf/RevisedSF424.pdf

 - **b.** An SF-424A Budget Information Form, which is available at http://apply07.grants.gov/apply/FormLinks?family=15. Enter only the PY 2013 allotment on the SF-424A. Do not include projected carry-in. In preparing the

Budget Information Form, the applicant must provide a concise narrative explanation to support the budget request, explained in detail below.

c. Budget Narrative: The budget narrative must provide a description of costs associated with each line item on the SF-424A.

Unexpended grant funds that were obligated for PY 2011 through PY 2012 must be expended during PY 2013, on a first-in/first-out basis, as these funds have a three-year period of availability from date of obligation. The period of performance for the grants ends on June 30, 2014.

Grantees that do not have prior year funds available may use other (non-restricted) funds to begin operating the SYSP or CSP, and reimburse the fund source retroactive to April 1 or July 1, upon availability of funds for allowable costs. The grantee cannot be reimbursed for funds spent prior to the date that the funds became available for obligation. Therefore, a formal commitment or obligation of DOL funds will only occur when a NOO has been issued by the Grant Officer. Grantees that incur costs prior to receiving an official "designation" letter and a NOO/award letter from the Grant Officer assume the risk of not being reimbursed for funds that have been used for their WIA section 166 program.
