- 1. <u>Purpose</u>. To update directions for determining whether youth live in a high poverty area for Workforce Innovation and Opportunity Act (WIOA) Title I Youth Program eligibility purposes.

## 3. <u>Summary and Background</u>.

- a. Summary This TEGL 21-16, Change 1 provides updated directions for using Census data to determine high-poverty areas for the WIOA Youth Formula Program.
- Background TEGL 21-16 *Third Workforce Innovation and Opportunity Act (WIOA) Title I Youth Formula Program Guidance*, issued on March 2, 2017, contains directions for determining high-poverty areas. Since the TEGL was posted, the Census Bureau changed its website, which changed the links in the directions found in Attachment 2. This TEGL change simply provides a link to updated instructions on how to use Census data to determine high-poverty areas. For all other guidance contained in TEGL 21-16, states and local WIOA Youth Programs should continue to use TEGL 21-16.
