**SUBJECT:** Directory of Federal Civilian and Military Agencies Requesting Quarterly Unemployment Compensation for Federal Employees (UCFE) or Unemployment Compensation for Ex-Servicemembers (UCX) Detailed Benefit Payment Data

**1. Purpose.** To provide an updated directory of Federal civilian and military agencies that have requested detailed benefit payment data, which supports the Department of Labor's quarterly unemployment compensation billings.

**2. References.** ET Handbook 401, 4<sup>th</sup> edition, ETA 191, Statement of Expenditures and Financial Adjustments of Federal Funds for Unemployment Compensation for Federal Employees and Ex-Servicemembers; Unemployment Insurance Program Letter No. 20-10; and Training and Employment Notice (TEN) No. 14-08.

**3. Background.** TEN 14-08 informed State Workforce Agencies (SWAs) that they are required to furnish to Federal agencies, upon their request, detailed benefit payment data, which supports charges contained in section B of the ETA 191 report. Once a Federal agency has requested detailed benefit payment data, the SWAs are required to furnish this data to the Federal agency each quarter. All the Federal agencies listed in the attached directory have requested that such data be sent to them. Federal agencies use this benefit payment data to reconcile the charges against billings they receive from the Department of Labor.

**4. Action Requested.** State administrators are requested to provide this advisory and attachment to appropriate staff. Detailed benefit payment data should be forwarded directly to the requesting Federal agencies by the 25<sup>th</sup> day of the month following the end of the reporting quarter.

**5. Inquiries.** Questions should be addressed to the appropriate Regional Office.

**6. Attachment.** Directory of Federal Civilian and Military Agencies Requesting Quarterly UCFE or UCX Detailed Benefit Payment Data.

5 U.S.C. 8509(c)(1) requires each employing Federal agency to reimburse the costs incurred by State Workforce Agencies (SWAs) for payment of regular and extended Unemployment Compensation for Federal civilian Employees (UCFE). Public Law 97-362 requires the Department of Defense to reimburse the costs incurred by SWAs for payment of regular and extended Unemployment Compensation for Ex-Servicemembers (UCX) attributed to all Federal military service.

Upon request, Federal agencies are to be provided with detailed benefit payment data which support those charges and adjustments which are included on the certified billing document for the quarter. The attached directory represents both the Federal civilian and military agencies that have requested the quarterly detailed data.
