- 1. <u>Purpose</u>. To announce the availability of funding for travel costs associated with state UI appellate staff attending the 2023 UI Appellate Professionals Training Conference scheduled to be held June 27-30, 2023, in Denver, Colorado.

## 3. Summary and Background.

- a. Summary The National Association of Unemployment Insurance Appeals Professionals (NAUIAP), a professional organization dedicated to UI appeals, will conduct a national training conference for state UI appellate professionals on June 27-30, 2023, in Denver, Colorado. This training conference is an important national forum that will highlight Employment and Training Administration (ETA) initiatives and provide updated information on recent legislation, regulations, and guidance affecting appeals operations.
