- SUBJECT: New Access to Do Not Pay (DNP) Data Sources through the Integrity Data Hub (IDH) Webinar
- 1. <u>Purpose</u>. To announce the New Access to DNP Data Sources through the IDH Webinar, which is scheduled to occur on July 23, 2024, at 2:00 p.m. (Eastern Time).
- 2. <u>Action Requested</u>. The Department of Labor's (Department) Employment and Training Administration (ETA) requests State Workforce Agency Administrators provide the information contained in this Training and Employment Notice (TEN) to appropriate program integrity and other staff in the state Unemployment Insurance (UI) system and encourage staff to participate in the upcoming webinar on this topic.

3. <u>Summary and Background</u>.

- a. Summary This TEN announces a national webinar for states to learn more about the DNP data sources and services being made available to state UI programs through the IDH.
- b. Background On May 2, 2024, the Department issued TEN. No. 28-23, announcing a new data sharing partnership between the U.S. Department of Treasury's Bureau of the Fiscal Service (Fiscal Service) Office of Payment Integrity (OPI) and the National Association of State Workforce Agencies' (NASWA) UI Integrity Center to provide state UI agencies access to Fiscal Service's DNP data sources and services through the IDH. TEN No. 28-23 also encourages states to immediately update their IDH Participation Agreement to Version 6.0, allowing states access to the DNP data sources and services when they become available and to take full advantage of other new IDH enhancements as they are deployed.
- 4. <u>Webinar Details</u>. ETA will host a national webinar to provide more details on the new data sharing partnership between Fiscal Service's OPI and the UI Integrity Center. This new partnership makes DNP data sources and services accessible to state UI agencies through the IDH. Speakers from Fiscal Service's OPI will share information about DNP and the value it offers in supporting state UI programs with payment integrity efforts. Additionally, attendees will hear from the UI Integrity Center's IDH team, who will provide updates on DNP implementation status, as well as other important IDH enhancements under
