No material or substantive change is made to the currently approved collection. Two ETA forms were erroneously assigned number 9165 and this action corrects that error. The only change is that the collection is now numbered ETA Form 9178. All references to the ETA Form 9165 in prior UIPLs shall be considered as referencing ETA Form 9178. This includes all UIPLs listed in the References section of this document.
4. **Action Requested.** State administrators should distribute this advisory to appropriate staff and ensure that the correct Attachment with the new ETA Form 9178 number is used.
