**SUBJECT:** Social Security Annuities and Federal Civilian Pensions

- 1. <u>Purpose</u>. To ensure that states are aware that: 1) the social security survivors and old age retirement annuities and the Federal civilian pensions annual cost-of-living adjustment (COLA) will increase for calendar year 2020 and 2) COLA information is located on the U.S. Office of Personnel Management (OPM) website.
- **2.** <u>Action Requested.</u> State Administrators should provide the information contained in this Unemployment Insurance Program Letter (UIPL) to appropriate staff.

## 3. Summary and Background.

**Summary.** This UIPL provides the website link to the 2020 COLA information and informs states to make necessary programming adjustments to accommodate the COLA increase.

**Background.** Each year, OPM posts the COLA information for social security survivors and old age retirement annuities and Federal civilian pensions on its website.
