**SUBJECT:** Extension of Time for States to Express Interest in the Grant Opportunity

Announced in Unemployment Insurance Program Letter (UIPL) No. 02-22, to Support States Following a Consultative Assessment for Fraud Detection and Prevention, Promoting Equitable Access, and Ensuring the Timely Payment of Benefits, including Backlog Reduction, for all Unemployment Compensation

(UC) Programs

1. <u>Purpose</u>. To notify states the deadline for expressing interest in the grant opportunity announced in UIPL No. 02-22, Change 1, is extended to March 31, 2023; and to provide updated guidance on Tiger Team grant funding submission(s), including updated SF-424 instructions.

**2.** <u>Action Requested.</u> The U.S. Department of Labor's (Department) Employment and Training Administration (ETA) requests that State Workforce Agency Administrators provide information contained in this UIPL to appropriate staff.

## 3. Summary and Background.

a. Summary—On November 2, 2021, the Department issued UIPL No. 02-22 announcing the availability of up to \$200 million to be awarded to states that engage in a consultative assessment with the Department's Tiger Teams and agreed to implement recommendations to enhance their UC systems and business processes to: 1) prevent and detect fraudulent activity, and to recover funds from fraud; 2) promote equitable access; and 3) ensure timely payment of benefits and reduce backlogs across all UC programs. To be eligible for the grant funding opportunity, states interested in participating in a Tiger Team consultative process were requested to express interest by March 31, 2022. On February 16, 2022, the Department issued UIPL No. 02-22, Change 1, extending the deadline for states to express interest in the Tiger Team consultative process to September 30, 2022. This UIPL extends the deadline to March 31, 2023. Additionally, this UIPL provides updated application instructions, with Attachment I to this UIPL replacing Attachment II to UIPL No. 02-22.

Since the development of the Department's Tiger Teams, twenty-four (24) states have engaged in the consultative assessment process as a means to access funds for agreed upon, near-term recommendations to states to strengthen program integrity; optimize operational processes and procedures to ensure timely payment of benefits; and promote equitable access to UC programs.

b. Background – On March 11, 2021, the President signed the American Rescue Plan Act of 2021 (ARPA) into law (Public Law (Pub. L.) 117-2). Section 9032, ARPA, creates a new Section 2118 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act (Pub. L. 116-136) and provides a \$2,000,000,000 appropriation to the Secretary of Labor to detect and prevent fraud, to promote equitable access, and to ensure timely payment of benefits to eligible workers with respect to UC programs.

In June 2022, the U.S. Government Accountability Office (GAO) added "the UI system to its list of federal areas at 'High Risk' for waste, fraud, abuse, and mismanagement, or in need of broad-based transformation." The GAO report explains that the UI system was added to the list "to bring greater attention to the challenges facing UI and to help spur needed changes."

- **4.** Guidance. Section 4.b. of UIPL No. 02-22 sets out the steps necessary for states to express an interest in the grant opportunity made available through that UIPL. Attachment I to UIPL No. 02-22 identifies the available funding allotment for each state. Section 5.c. of UIPL No. 02-22 provides the application instructions for submitting form SF-424. Section 4 of UIPL No. 02-22, Change 1, provides that the deadline for expressing an interest in a Tiger Team consultative assessment is September 30, 2022. This UIPL makes the following changes to guidance:
  - a. Provides updated instructions for completing the SF-424 as set out in Attachment I (which replaces Attachment II in UIPL No. 02-22). These updated instructions include an amendment to the end date period of performance of the grant awards to two years from the start date of the award and instructions for the states to submit the SF-424a (OMB No. 4040-0006) when applying for grant awards, <a href="https://apply07.grants.gov/apply/forms/instructions/SF424A-V1.0-Instructions.pdf">https://apply07.grants.gov/apply/forms/instructions/SF424A-V1.0-Instructions.pdf</a>. Once a state and ETA agree on the assessment recommendations to implement, states should to submit these forms via <a href="https://www.grants.gov">www.grants.gov</a>.
  - b. Based on the initial success of this initiative as a means of technical assistance to states and given the U.S. Government Accountability Office's (GAO) designation of "the UI system to its list of federal areas at 'High Risk' for waste, fraud, abuse, and mismanagement, or in need of broad-based transformation," the Department is strongly encouraging states to express interest in this consultative assessment and grant opportunity. The Department recognizes that states may need additional time to ensure they have the appropriate supports in place to foster a successful consultative process. This UIPL is extending the deadline for states to request participation in a consultative assessment with the Department to March 31, 2023. States should express such interest by contacting their appropriate ETA Regional Office.

The Department encourages all states that have not yet participated in a Tiger Team consultative assessment to take advantage of the extensive UI subject matter expertise and resources offered through this grant opportunity.

Use the current version of the form for submission. Expired forms will not be accepted. SF-424, Office of Management and Budget (OMB) Control No. 4040-0004 (Grants.gov). https://apply07.grants.gov/apply/forms/sample/SF424\_4\_0- V4.0.pdf

#### **Section #8, APPLICANT INFORMATION:**

- <u>Legal Name</u>: The legal name must match the name submitted with the System for Award Management (SAM). Please refer to instructions at <a href="https://sam.gov/content/home">https://sam.gov/content/home</a>.
- <u>Employer/Tax Identification Number (EIN/TIN)</u>: Input your correct 9-digit EIN and ensure that it is recorded within SAM.
- <u>Unique Entity Identifier (UEI)</u>: Starting on April 4, 2022, the DUNS Number was replaced by a new, non-proprietary identifier requested in and assigned by the System for Award Management (SAM) at SAM.gov. This new identifier is being called the Unique Entity Identifier (UEI), or the Entity ID.
