**SUBJECT:** Discontinuation of Internal Revenue Service (IRS) Data Submissions for the

Health Coverage Tax Credit (HCTC) for Eligible Trade Adjustment Assistance (TAA) Recipients and Alternative TAA (ATAA) and Reemployment TAA

(RTAA) Recipients

1. <u>Purpose</u>. To advise states about their responsibilities related to the HCTC program.

2. Action Requested. The U.S. Department of Labor's (Department) Employment and Training Administration (ETA) requests that State Workforce Agency (SWA) Administrators share information contained in this Unemployment Insurance Program Letter (UIPL) with appropriate staff. States must cease submitting HCTC data to the Unemployment Insurance Interstate Connection Network (ICON) system, operated by National Association of State Workforce Agencies (NASWA), as soon as possible.

#### 3. Summary and Background.

- a. Summary The HCTC program expired on December 31, 2021. Since then, many states have continued to submit HCTC data via ICON. The IRS has informed ETA that it is officially closing HCTC operations and will no longer be able to receive files pertaining to HCTC. Attachment I to this UIPL identifies the applicable ETA Advisories that are canceled as a result of this change.
- b. Background Title II of the TAA Reform Act of 2002 (Public Law (Pub L.) 107-210) created the initial HCTC Federal income tax credit, which subsidizes certain health insurance coverage for eligible Pension Benefit Guaranty Corporation (PBGC) recipients as well as certain individuals in the TAA Program. The Consolidated Appropriations Act, 2021, (Pub. L. 116-260), enacted on December 27, 2020, extended the HCTC Program through December 31, 2021. Congress did not extend the program and it is now expired.

Before the expiration of the HCTC on December 31, 2021, states transmitted the records of eligible TAA and ATAA/RTAA recipients to the IRS via ICON. Upon receipt of the

file from the states, the IRS determined whether the eligible TAA and ATAA/RTAA recipients were eligible for HCTC.

#### 4. Cessation of HCTC data transmission via ICON and cancellation of related advisories.

- a. Effective immediately, states must cease transmission of the HCTC files via ICON.
- b. States must inform the appropriate ETA Regional Office when the transmissions have ceased or will cease.
- c. Due to the cessation of the HCTC program, the Department is cancelling multiple Training and Employment Notices (TENs) and UIPLs relating to the program. (See Attachment I).
