- **SUBJECT:** Minimum Disaster Unemployment Assistance (DUA) Weekly Benefit Amount: October 1 – December 31, 2024
- <u>Purpose</u>. To transmit the subject computation for State Workforce Agency usage in computing minimum weekly DUA amounts for all major disasters declared from October 1 – December 31, 2024 (first quarter of Fiscal Year (FY) 2025).
- 2. <u>Action Requested</u>. The Employment and Training Administration (ETA) requests that State Workforce Agency Administrators provide this information to appropriate staff and ensure their state uses the correct Average Weekly Benefit Amount (AWBA) in determining the minimum weekly DUA benefit amount.

3. Summary and Background.

- a. Summary If an individual's DUA weekly benefit amount is less than 50 percent of the state's AWBA for Unemployment Compensation (UC) or if the individual has insufficient wages from employment or insufficient or no net income from self-employment to establish a DUA weekly benefit amount, the state shall determine the minimum DUA weekly amount to equal 50 percent of the AWBA of UC in the state.
- b. Background –The Department is required to publish information on each state's minimum DUA weekly benefit amount quarterly (see 20 CFR 625.6(b)).

4. Minimum Disaster Unemployment Assistance (DUA) Weekly Benefit Amount.

The attached listing sets forth the minimum DUA weekly benefit amount for each state applicable for major disasters declared during the first quarter of FY 2025, from October 1 - December 31, 2024, and the computation used to determine this amount.
