

## I. Significant Migrant and Seasonal Farmworker (MSFW) States <sup>1</sup>

The following states are designated as significant MSFW states.

[20 CFR 653.107\(a\)\(4\)](#), as revised by the [Wagner-Peyser Staffing final rule](#), requires that each SWA must ensure that there are an adequate number of outreach staff employed in the state to conduct MSFW outreach in each service area of the state and to contact a majority of MSFWs in the state annually. In the 20 states with the highest estimated year-round MSFW activity, as identified by the Department, there must be full-time, year-round outreach staff to conduct outreach duties. Full-time means each individual outreach staff person must spend 100 percent of their time on the outreach responsibilities described in [paragraph \(b\)](#) of this section. For the remainder of the states, there must be year-round part-time outreach staff, and during periods of the highest MSFW activity, there must be full-time outreach staff. These staffing levels must align with and be supported by information about the estimated number of farmworkers in the state and the farmworker activity in the state as demonstrated in the state's Agricultural Outreach Plan (AOP) pursuant to [20 CFR 653.107\(d\)](#). All outreach staff must be multilingual, if warranted by the characteristics of the MSFW population in the state, and must spend a majority of their time in the field.

Note: Arkansas, New York, and Wisconsin were not designated as significant MSFW states in program year (PY) 2022 but they are designated as significant MSFW states for PY 2023, which began July 1, 2023. Arkansas, New York, and Wisconsin must comply with the requirements at [20 CFR 653.107\(a\)\(4\)](#) to have full-time, year-round outreach staff by the beginning of the fourth quarter of PY 2023 on April 1, 2024.
