## U.S. Department of Labor Announces over \$42 Million in Youth Apprenticeship Readiness Grant Awards to Increase Youth Participation in Registered Apprenticeships

**WASHINGTON, DC** – The U.S. Department of Labor's Employment and Training Administration (ETA) today announced the award of \$42,296,247 in Youth Apprenticeship Readiness grants to 14 organizations to increase participation by youth, ages 16 to 24, in new or existing Registered Apprenticeship Programs (RAPs).

"As young men and women prepare for productive careers in a changing economy, apprenticeships can provide valuable skills and job opportunities while avoiding large student loan debt," said Secretary of Labor Eugene Scalia. "The grants announced today will play an important role in helping schools and other educational entities expand apprenticeship opportunities for young Americans."

"The Youth Apprenticeship Readiness grants continue the U.S. Department of Labor's and the President's commitment to expanding the apprenticeship model here in America," said Assistant Secretary for Employment and Training John Pallasch. "These grants will provide young people with new apprenticeship opportunities that can lead to successful and fulfilling careers."

In June 2017, the President issued an Executive Order on Expanding Apprenticeships in America that focused on developing new apprenticeships in secondary and post-secondary institutions and increasing youth participation. This grant program supports the order to expand access to youth apprenticeships, to promote pre-apprenticeship programs, and to develop a strong youth apprenticeship pipeline.

These grants will allow educational entities—including traditional, alternative, and nontraditional schools; and programs that serve out-of-school youth, school boards, workforce boards, employers, workforce partners, and other apprenticeship intermediaries—to partner to develop and establish new apprenticeship models for youth or expand existing apprenticeship programs for youth.

Grant recipients will seek to expand opportunities to prepare 16 to 24 year old registered apprentices for careers in industries including manufacturing, information technology, cybersecurity, and healthcare.
