

FINDINGS AND PERCEPTIONS ON CHILD LABOR IN AGRICULTURE



EXPOAGRO SURVEY

- **53%** had a work experience before age 18.
- **54%** approve that children and adolescents work in the farming sector.
- **9** out of every **10** are not aware of the national child and adolescent labor legislation

INTA MENDOZA SURVEY

- **87%** saw children and adolescents performing agricultural activities.
- **81%** acknowledge the presence of children and adolescents in housekeeping or care activities.
- **66%** do not approve that children and adolescents work rural sector.
