2024 Veteran Employment Data Catalog

SUMMARY

In 2022, the Chief Evaluation Office (CEO) partnered with the Veterans Employment and Training Service (VETS) to fund contractor Westat to conduct the 2024 Veteran Employment Data Catalog. The data catalog aims to assist researchers by identifying existing public and restricted datasets related to the post-separation civilian transition, racial equity, and support for underserved veteran communities.

This catalog provides reference entries for 19 datasets that contain data related to these topic areas. Each dataset entry includes a description, potential research utility, strengths and limitations, sampling metadata, a list of relevant included variables, data structure metadata, and data accessibility metadata. Researchers can use this catalog to (1) find datasets containing variables related to their research questions, (2) gain an overview of a dataset's general relevance to veteran employment-related content, and (3) anticipate the types of veteran employment-related inquiries a dataset may be able to support.

This Department of Labor-funded study was a result of VETS's desire to identify a comprehensive list of data sources with information on the veteran status and employment outcomes of individuals and assess the value of these data sources for VETS analytic needs. It contributes to the labor evidence-base to inform Data, Methods, and Tools, Employment and Training, Disability and Employment, and Equity, and addresses Departmental strategic goals and priorities.

The 2024 Veteran Employment Data Catalog is part of the CEO's Administrative Data Research and Analysis (ADRA) program. ADRA identifies and examines administrative data sets from federal agencies to inform changing agency priorities. ADRA's studies focus on data that can help build evidence-based research to support Department strategic goals.
