agreed to settle and resolve all FLSA violations attributable to Defendant through this Consent Judgment.

E. The Parties agree to waive findings of fact and conclusions of law and agree to the entry of this Consent Judgment without further contest.

5 F. Defendant admits that the Court has jurisdiction over the parties and subject
6 matter of this civil action and that venue lies in the District of Arizona.

7 G. Defendant engages in exterior stucco and plastering construction, including
8 lath work on residential single-family homes.

- 9 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that, pursuant to
 10 Section 17 of the FLSA, 29 U.S.C. § 217, Defendant, its officers, agents, servants,
 11 employees, successor companies, parties in interest, and all persons and entities acting at
 12 its direction or in concert or participation with them, are permanently enjoined and
 13 restrained from violating the FLSA, including through any of the following manners:
- Defendant shall not, contrary to the FLSA § 7, 29 U.S.C. § 207, employ any
 non-exempt employee who in any workweek is engaged in commerce, within the meaning
 of the FLSA § 3(s), or is employed in an enterprise engaged in commerce or in the
 production of goods for commerce, within the meaning of FLSA § 3(s), for any workweek
 longer than 40 hours unless such employee receives compensation for their employment in
 excess of 40 hours in such workweek at a rate not less than one and one-half times the
 regular rate at which they are employed.
- 2. Defendant shall not fail to make, keep, make available to authorized agents
 of the Secretary for inspection, transcription, and/or copying, upon their demand for such
 access, and preserve records of employees and of the wages, hours, and other conditions
 and practices of employment maintained, as prescribed by regulations issued, and from
 time to time amended, pursuant to FLSA §§ 11(c) and 15(a)(5), 29 U.S.C. §§ 211(c) and
 215(a)(5) and the implementing regulations found in Title 29, Code of Federal Regulations,
 Part 516.

3. Defendant shall comply with the FLSA and, if not already in effect at the

2

time of entry of this Consent Judgment, shall amend and maintain its payroll practices as follows:

3 Defendant shall accurately record the information required by 29 C.F.R. § a. 4 516.2 in the payroll records, including (1) all hours worked by employees each workday 5 and workweek; (2) the rate(s) of pay for each of the hours worked during a workweek; (3) 6 the total weekly straight-time earnings due for the hours worked during the workweek; (4) 7 the total premium pay for overtime hours; and (5) if Defendant chooses to calculate pay 8 through any type of production-based system, such as a piece rate system, Defendant shall: 9 a) notify employees of the standard applicable piece rate to be paid in writing, and keep a 10 written record of any changes to or deviations from the standard applicable piece rate; c) 11 maintain a record of the identities of all employees working on any "crew" to which a given 12 employee is assigned; d) maintain a record of the precise formula used to calculate how 13 each employees' weekly pay, including overtime pay, is calculated, and make such information open to each employee for inspection; e) calculate overtime at time and one-14 15 half the employee's regular rate (the regular rate is calculated by dividing the employee's 16 total weekly earnings before any deductions are made by the total number of hours worked 17 in that workweek); and f) show all deductions on the employee's weekly paystub along 18 with an explanation of the deductions.

19 b. Defendant's timekeeping system shall permit employees (as opposed to 20 supervisors) to track their individual work hours daily. If changes in the time records later 21 are required, Defendants shall designate and authorize one or more individuals to correct 22 time entry errors. Crew leaders and superintendents may not change or edit employee 23 entered hours on a time sheet. Defendant will dedicate an individual to train employees on 24 filling out time cards and perform periodic checks of timecards at various worksites. This 25 provision shall remain in effect for three years or until an electronic timekeeping system is 26 implemented for all employees.

c. Defendant shall maintain all time, piece rate, and payroll records for a period
of not less than three years.

- d. Defendant shall record all wages paid to employees, regardless of the manner of payment, on its payroll records, and any expense reimbursements must be recorded in Defendant's accounting system.
- e. Defendant shall inform all supervisors, managers, and persons performing payroll duties of the requirements of this Consent Judgment and shall provide a copy of this Consent Judgment to all supervisors, managers, and persons performing payroll duties.

f. Defendant shall direct their supervisors, managers, and persons performing payroll duties to encourage workers to report all hours worked and piece rate work.

- 9 4. Defendant, its officers, agents, servants, and employees and those persons in
 active concert or participation with them, shall not in any way directly or indirectly,
 demand, require or accept any of the back wages or liquidated damages from any of the
 employees listed on the attached Exhibit A. Defendant shall not threaten or imply that
 adverse action will be taken against any employee because of their receipt of funds due
 under this Consent Judgment. Violation of this Paragraph may subject the Defendant to
 equitable and legal damages, including punitive damages and civil contempt.
- 5. Defendant, its officers, agents, servants, and employees and those persons in
 active concert or participation with them, shall not in any way retaliate or take any adverse
 employment action, or threaten or imply that adverse action will be taken against any
 employee who exercises or asserts their rights under the FLSA or provides information to
 any public agency investigating compliance with the FLSA. Violation of this Paragraph
 may subject the Defendant to equitable and legal damages, including punitive damages and
 civil contempt.
- 6. Defendant shall not continue to withhold the payment of \$350,606.50 in
 overtime pay hereby found to be due by the Defendant under the FLSA to employees, as a
 result of their employment by Defendant during the period of May 15, 2019 through March
 25, 2022 ("Back Wage Accrual Period").
- FURTHER, JUDGMENT IS HEREBY ENTERED, pursuant Section 16(c) of
 the FLSA, 29 U.S.C. § 216(c), in favor of the Secretary and against Defendant in the

amount of \$725,000. Pursuant to this Judgment, IT IS HEREBY ORDERED THAT

7. Defendant shall pay \$350,606.50 in overtime pay hereby due under the FLSA and this Judgment, to employees on Exhibit A. In addition, liquidated damages in the amount of \$350,606.50 are hereby due under the FLSA and Defendant shall pay this amount to the employees on Exhibit A.

8. The amount of \$23,787 in civil money penalties is assessed against Defendant and finally determined, pursuant to FLSA Section 16(e), 29 U.S.C. § 216(e).

9. Defendant will comply with Paragraphs 7 and 8 of this judgment by making payment on or before January 31, 2023.

10

10. To accomplish the requirements of Paragraph 7, Defendant shall:

a. Deliver a check or money order to each person named in the attached Exhibit
A, less the amounts of legal deductions for payroll and withholding taxes thereon (that
Defendant shall pay directly to the federal and state agencies entitled thereto when due).

b. Within thirty (30) days of each payment made pursuant to Paragraph 7,
deliver to the U.S. Wage and Hour Division evidence of payment to each person paid,
including any and all signed U.S. Wage and Hour Division Receipt for Payment of Back
Wages, Employment Benefits, or Other Compensation Form WH-58 receipt forms or
copies of canceled checks the Defendant has received at that time.

19 On or before March 30, 2023, provide the U.S. Wage and Hour Division with c. 20 a list of all employees who could not be located or who refused to accept any payment 21 made according to Exhibit A, their last known address, phone number, social security 22 number, and their gross and net amounts due, and shall deliver to the U.S. Wage and Hour 23 Division one cashier's or certified check, payable to "Wage and Hour Division – U.S. Dept. 24 of Labor" to cover the total back wage and liquidated damages amount due to all employees 25 listed in Exhibit A to be paid on that date who could not be located or who refused payment. 26 Defendant may also make this payment online by ACH transfer, credit card, debit card, or 27 digital wallet by going to https://www.pay.gov/public/form/start/77761888, or by going to 28 www.pay.gov and searching "WHD Back Wage Payment - WE Region." Payments shall

11. To accomplish the requirement of Paragraph 8, the Parties acknowledge that Defendant has made the payment of civil money penalties required by this Consent Judgment online by ACH transfer, credit card, debit card, or digital wallet by going to https://www.pay.gov/public/form/start/77761888, or by going to www.pay.gov and searching "WHD Back Wage Payment - WE Region", or Civil Money Penalties as applicable. Payments shall reference Case Number # 1937100.

8 12. In the event of any default in the timely making of any payment due 9 hereunder, the full amount due under the back wage provisions of this Judgment which 10 then remains unpaid, plus post-judgment interest at the rate of 10% per year, from the date 11 of this Judgment until paid in full, shall become due and payable upon the Secretary's 12 sending by ordinary mail a written demand to the last business address of Defendant then 13 known to the Secretary with electronic copies also concurrently e-served on Defendant's 14 counsel of record.

15 13. Within sixty (60) days of the entry of this Judgment, Defendant shall hire a
third party to conduct training for all of Defendant's supervisors, managers, and persons
performing payroll duties on the requirements of the FLSA, including the overtime,
recordkeeping, and anti-retaliation provisions. The training shall include: (a) when
employees must be paid for overtime, including overtime with respect to piece rate work;
(b) recordkeeping; and (c) an overview of the system for reporting FLSA concerns set forth
in Paragraph 16 of this Judgment.

14. Within fifteen (15) days of the training enumerated in Paragraph 13,
Defendant shall deliver to the U.S. Wage and Hour Division evidence that all supervisors
attended the training. Evidence may be provided in the form of a sign-in sheet and may be
sent by electronic mail to wood.mitchell@dol.gov.

26 15. Within sixty (60) days of the entry of this Judgment, Defendant shall
27 implement a system for employees to report overtime and minimum wage concerns to
28 Defendant. The mechanism must include a requirement that all reports of overtime and

minimum wage concerns be reported to Defendant's senior management team.

16. Within sixty (60) days of the entry of this Judgment, Defendant shall amend or develop as necessary Defendant's employee Handbook that Defendant provides its employees to include a policy (or policies) notifying employees of their entitlement to minimum wage and overtime compensation.

6 17. Within thirty (30) days of the entry of this Judgment, Defendant shall supply all of its employees with copies of the attached Exhibit B. In addition, Defendant shall provide copies of Exhibit B to all new hires and post a copy at a work location where it is visible to employees for the period of two (2) years from the date of entry of this Consent Judgment.

11 IT IS FURTHER ORDERED that the filing, pursuit, and/or resolution of this 12 proceeding with the entry of this Judgment shall not act as or be asserted as a bar to any 13 action or claim under FLSA § 16(b), 29 U.S.C. § 216(b), as to any employee not named on 14 the attached Exhibit A, nor as to any employee named on the attached Exhibit A for any 15 period not specified therein, nor as to any employer other than Defendant.

16 IT IS FURTHER ORDERED that each party shall bear their own fees, costs, and 17 other expenses incurred by such party in connection with any stage of this proceeding, 18 including but not limited to attorneys' fees, which may be available under the Equal Access 19 to Justice Act, as amended, to the date of entry of the Judgment herein; and

IT IS FURTHER ORDERED that this Court retains jurisdiction of this action for purposes of enforcing compliance with the terms of this Consent Judgment.
