a) Johnnie McDade Grocery, 1763 Vinson Highway SE, Milledgeville, GA-On or about May 27, 2021 and thereafter, the employer did not develop and implement timely and effective measures to mitigate the spread of SARS-CoV-2, the virus that causes Coronavirus Disease 2019 (COVID-19). Employees at the cash register, aisles, and office area worked in close proximity to each other during the COVID-19 pandemic. These conditions allowed the perpetuation of an outbreak of COVID-19 at the facility.

Among other methods, a feasible and acceptable means of abatement would be to develop, implement, and train employee(s) on a COVID-19 Prevention Program that includes, at a minimum, the following protocols:

- 1. Establish and implement physical distancing measures to ensure that anyone in the workplace maintains at least a six-foot distance between other employees, customers, and visitors (e.g. floor demarcations, occupancy limits);
- 2.Install transparent, impermeable barriers at customer-facing stations, lunch rooms, break areas and in other common areas if physical distancing is not possible;
- 3. Perform routine cleaning and disinfection, especially high contact surfaces, and provide cleaning supplies and notouch trash cans;
- 4. Provide training on the sources of exposure to COVID-19, the hazards associated with that exposure, and the workplace protocols in place to prevent or reduce the likelihood of exposure. Train on the use of face coverings, how to maintain a safe distance, and the appropriate workplace methods and procedures in place to prevent and reduce exposure;
- 5. Encourage employees to get vaccinated, as appropriate under applicable laws and/or labor management contracts.
- 6. Instruct workers who are sick to stay home. Screen employee(s) for COVID-19 symptoms. If they have symptoms before or during work, immediately send them home and encourage them to seek medical attention;
- 7. Establish, implement, and enforce a program requiring anyone in the workplace to wear face coverings (e.g. cloth face coverings, surgical masks); and
- 8. Follow federal, state, and local mandates, guidance, and recommendations to ensure public safety and health related to COVID-19.

The debit from your account will then usually occur within 24 hours and will be shown on your regular account statement. You will not receive your original check back. The bank will destroy your original check, but will keep a copy of it. If the EFT cannot be completed because of insufficient funds or closed account, the bank will attempt to make the transfer up to two times.

Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of

Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

<u>Interest</u>: Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

<u>Delinquent Charges</u>: A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

<u>Administrative Costs</u>: Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt. Administrative costs will be assessed for demand letters sent in an attempt to collect the unpaid debt.
