The employee was "running the rafters" and installing stay laps at the top of the roof, exposing to an approximate 27-foot drop on the back side of the house and an 18-foot drop on the front of the house. The roof had an 8/12 pitch on either side. He was not utilizing guardrail systems, a safety net system, or a personal fall arrest system. The employee was observed on the roof of the building without fall protection, exposing him to falls to the ground below.
