OSH ACT of 1970 Section (5)(a)(1): The employer did not furnish employment and a place of employment which were free from recognized hazards that were causing or likely to cause death or serious physical harm to employees, in that employees were not protected from the hazard of high heat while performing their jobs duties.

- a) On or about December 2, 2023, at the orange grove located at 12010 FL-70, Arcadia, Florida 34266, employees were exposed to the hazard of high heat from the sun during the performance of their job duties, including picking oranges. The calculated Wet Bulb Globe Temperature (WBGT) ranged from 23°C- 29°C (74°F to 83°F) with a calculated heat index of 24°C- 33°C (74°F to 92°F) while working outdoors for approximately 8-9 hours performing heavy manual labor and wearing long sleeves, long pants, and a hat. An employee assigned to perform harvesting experienced adverse health effects such as, but not limited to, heat cramps and heat exhaustion, from exposure to the hot work environment.
- b) On or about December 3, 2023, at the orange grove located at 12010 FL-70, Arcadia, Florida 34266, employees were exposed to the hazard of high heat from the sun during the performance of their job duties, including picking oranges. The calculated Wet Bulb Globe Temperature (WBGT) ranged from 23°C- 30°C (73°F to 86°F) with a calculated heat index of 23°C- 35°C (74 °F to 95°F) while working outdoors for approximately 4-5 hours performing heavy manual labor and wearing long sleeves, long pants, and a hat. An employee assigned to perform harvesting experienced adverse health effects such as, but not limited to, heat cramps and heat exhaustion, from exposure to the hot work environment.
- c) On or about and at times prior to December 4, 2023, at the orange grove located at 12010 FL-70, Arcadia, Florida 34266, employees were exposed to the hazard of high heat from the sun during the performance of their job duties, including picking oranges. The calculated Wet Bulb Globe Temperature (WBGT) ranged from 24 °C-29°C (74°F to 84°F) with a calculated heat index of 24°C-32°C (75°F to 90°F) while working outdoors for approximately 8-9 hours performing heavy manual labor and wearing long sleeves, long pants, and a hat. An employee experienced a heat stroke during his duties on December 4, 2023, and as a result of the exposure the employee died on December 7,2023 at the hospital.

One feasible and acceptable means of abatement would be to develop and implement an effective Heat Illness Prevention Plan, which would include:

a. Designate a program administrator responsible for implementing the heat stress program at a specific indicator, wet bulb globe temperature or dry-bulb temperature.

- b. Provide a training program, for all employees, which includes the health effects associated with heat stress, symptoms of heat-induced illness, methods of preventing such illnesses, and actions that should be taken in the event a heat-induced illness is experienced in a language and manner that employees understand.
- c. Acclimatize employees beginning work in hot environment or those returning form an absence period of three or more days. Establish clearly defined acclimatization procedures for returning employees and employees working where they are exposed to increased heat load.
- d. Encourage employees to drink a cup of cool water every 15 to 20 minutes rather than relying on thirst. For longer jobs that last more than two hours, also provide electrolyte-containing beverages.
- e. Establish specific-break schedules during high temperature conditions that are more frequent than regular break schedules. Ensure that these break schedules are followed.
- f. Provide a shaded area for breaks.
- g. Monitor workers, or signs and symptoms of heat related illnesses, to better identify when workers need to be removed from the work area.
- h. Conduct in-person evaluations of employees complaining of heat-related illness symptoms and ensure supervisors can use physical indicators to determine when it is appropriate to remove an employee from work, arrange for immediate medical attention, or provide other assistance as necessary.

If a personal check is issued, it will be converted into an electronic fund transfer (EFT). This means that our bank will copy your check and use the account information on it to electronically debit your account for the amount of the check. The debit from your account will then usually occur within 24 hours and will be shown on your regular account statement. You will not receive your original check back. The bank will destroy your original check, but will keep a copy of it. If the EFT cannot be completed because of insufficient funds or closed account, the bank will attempt to make the transfer up to two times.

Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

<u>Interest</u>: Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

Delinquent Charges: A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

<u>Administrative Costs</u>: Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt. Administrative costs will be assessed for demand letters sent in an attempt to collect the unpaid debt.
