Project Description

The project plans to provide participants with an array of career and training services leading to industry recognized credentials, work based learning through internships, fellowships, paid work experience, on-the-job training, and registered apprenticeships; provide customized services to meet participants where they are in their career journey; research and expand current virtual technology platforms; develop and launch an extensive outreach campaign including traditional channels and newer text message outreach, online radio campaigns, and social media.

Project Goals

The project will couple targeted outreach and individualized supportive services with training and employment services, connecting individuals from historically marginalized communities and groups with jobs that pay family-sustaining wages and have the promise of career growth. By bringing our services to targeted areas of our community and expanding virtual services, our program will be easier to access and broadly available throughout the county as well as outside of normal business hours helping to alleviate barriers to work.
