# June 30, 2015

Brian Whitfield was sentenced on June 8, 2015 to 20 years imprisonment with 3 years supervised release and the court ordered forfeiture in the amount of \$1,800,000.00 and restitution in the amount of \$25,949,533.58.

Marsha Whitfield was sentenced on June 25, 2015 to 5 years probation with 6 months in a halfway house and court ordered forfeiture in the amount of \$1,800,000.00 and restitution in the amount of \$3,736,635.43.

D. Edwin Todd was sentenced on June 25, 2015 to 5 years probation with 6 months under house arrest with electronic monitoring and court ordered forfeiture in the amount of \$245,855.00 and restitution in the amount of \$3,736,635.43.

### November 10, 2014

Brian Whitfield was convicted by a federal jury, of 14 fraud-related counts. The jury found Whitfield guilty of conspiracy, wire fraud, theft from an employee benefit program, filing a false tax return, and money laundering. Whitfield will be sentenced by Judge Campbell on January 26, 2015.

### October 7, 2014

The trial is currently scheduled for October 28, 2014 before U.S. District Chief Judge Todd J. Campbell. Victims and interested persons should be aware that trial schedules often change, many times with little advance notice. As such, anyone wishing to attend a given court hearing should confirm the date with the U.S. Attorney's Office's victim-witness coordinator before traveling to the hearing.

## July 9, 2012

The trial scheduled to begin on May 8, 2012 before U.S. District Chief Judge Todd J. Campbell has been continued until December 11, 2012 at 9:00 AM. The pretrial conference is now scheduled to take place on December 3, 2012 at 10:30 AM. *If a plea agreement is submitted,* the guilty plea hearing will take place on December 3, 2012 in lieu of the pretrial conference.
