ORDER DISMISSING APPEAL

On February 12, 2024 appellant filed a timely appeal from a November 7, 2023 merit decision of the Office of Workers' Compensation Programs (OWCP). The Clerk of the Appellate Boards assigned the appeal Docket No. 24-0337.

The Board, having duly considered this matter, notes that the Board and OWCP may not simultaneously exercise jurisdiction over the same issue(s) in a case on appeal.² By the November 7, 2023 decision, OWCP denied appellant's claim for an additional schedule award.

¹ Appellant's application for review (AB-1 Form) notes that he is also appealing from a purported December 18, 2023 OWCP decision. However, the case record does not contain a final adverse decision of that date. The case record contains correspondence dated December 18, 2023 from OWCP's Branch of Hearings and Review explaining that appellant's hearing request could not proceed at that time as the Board had concurrent jurisdiction over the same issue. This correspondence, however, does not constitute a final adverse OWCP decision from which appellant may properly appeal as it is informational in nature. *See Order Dismissing Appeal, K.S.*, Docket No. 20-1401 (issued March 17, 2021); *Order Dismissing Appeal, S.U.*, Docket No. 20-0636 (issued December 3, 2020).

However, on October 11, 2023, appellant had filed an appeal with the Board from April 21 and June 2, 2023 decisions regarding the same underlying issue, to which the Clerk of the Appellate Boards assigned Docket No. 24-0026. As the issue of whether OWCP properly paid appellant a schedule award was pending before the Board in Docket No. 24-0026 when OWCP issued its November 7, 2023 decision, OWCP's November 7, 2023 decision is null and void.³

As OWCP's November 7, 2023 decision is null and void, there is no final adverse decision issued by OWCP over which the Board may properly exercise jurisdiction. The Board, therefore, concludes that the appeal docketed as No. 24-0337 must be dismissed. Accordingly,

IT IS HEREBY ORDERED THAT the appeal docketed as No. 24-0337 is dismissed.
