DECISION APPROVING SETTLEMENT

Before: Judge Manning

1. These cases are before me upon 15 petitions for assessment of civil penalty under section 105(d) of the Federal Mine Safety and Health Act of 1977 (the "Act"). In total, the dockets include 119 citations and orders issued pursuant to Section 104 of the Act. The Secretary of Labor, Mine Safety and Health Administration, ("Secretary") proposed total penalties of \$583,444.00 for the fifteen dockets.

The parties have filed a "Joint Stipulations and Motion to Approve Settlement Agreement". The citations, orders, and penalties are affirmed as follows:

- 2. All citations and orders shall remain as issued.
- 3. Cemex de Puerto Rico ("Respondent") maintained that it would present evidence at trial that it does not have the ability to pay the total proposed penalties and remain in business. It provided the Secretary with documentation of its financial status. The Secretary in turn agreed to reduce the total proposed penalty by fifty percent (50%) to \$291,722, as apportioned herein below.
- 4. Respondent agrees to the following enhanced abatement measures to address and improve miner safety and health at its three MSHA regulated facilities in Puerto Rico:
- i. Respondent will hire at its expense an independent outside safety consultant who has knowledge of surface mining and cement plant operations to conduct a wall-to-wall employee safety audit of its three MSHA-regulated facilities (i.e., Ponce Cement Plant, Cantera Canas, and Florida Lime (Mine ID: 54-00194)) once annually in the years 2016, 2017, 2018, and 2019. The safety consultant shall provide a written report of its findings and the specific actions and recommendations it determines are necessary for Respondent to ensure its compliance with the Mine Act. A copy of these written reports shall be sent by the safety consultant to Respondent's manager responsible for safety at each facility. Respondent will maintain each audit report for a period of three years and will produce it to MSHA upon request. No action or non-action by MSHA shall constitute a waiver of this paragraph.

- ii. Respondent will contact MSHA Educational Field and Small Mine Services ("EFSMS") within thirty (30) days of the approval of this agreement to arrange for EFSMS to come to its facilities in Puerto Rico and teach a metal/non-metal mining safety course and cement plant safety course designed by EFSMS to the safety directors, assistant safety directors, area supervisors, and foremen of its three MSHA-regulated facilities. EFSMS will not charge Respondent for the provision of these courses. Respondent will compensate each of its aforesaid personnel attending the safety course at their normal rate of pay for their time attending the safety courses. At the time that Respondent contacts EFSMS to arrange the courses, EFSMS will determine whether Respondent's facility is suitable. If Respondent does not have a facility suitable to teach the class, as determined by EFSMS, Respondent will pay to rent a suitable facility in Puerto Rico.
- 5. Respondent's agreement to these enhanced abatement measures in no way preempts MSHA's statutory authority to conduct inspections of Respondent's facilities at any time or issue citations as deemed appropriate.
- 6. The total penalties of \$291,722.00 are apportioned to the individual citations and orders as follows:

^{8.} The agreed upon penalty amounts are consistent with the criteria set forth at 30 C.F.R. Part 100. The penalty amounts are reasonable given the circumstances surrounding the violations.

- 9. I have considered the criteria set forth at Section 110(i) of the Act and I find that the penalties are appropriate in light of these criteria and promote the purposes of the Act. Information pertaining to the operator's negligence, the gravity of the violations, its history of previous violations, and size are contained in the Exhibit A attached to the petition for each docket. Payment of the total amended proposed penalty will not adversely affect the operator's ability to continue in business.
- 10. Each party agrees to bear its own attorney's fees, costs, and other expenses incurred by such party in connection with any stage of these proceedings, including but not limited to, attorney's fees and costs which may be available under the Equal Access to Justice Act, as amended.
 - 11. This settlement fully resolves the above-captioned dockets.

Based on the foregoing, the motion to approve settlement is hereby **GRANTED**.

It is further **ORDERED** that Cemex De Puerto Rico pay the total penalty of \$291,722.00 in 24 consecutive monthly installments. The first 23 installments will be in the amount of \$12,155.08. The 24th installment shall be in the amount of \$12,155.16. The first monthly installment will be paid on or before July 1, 2016¹ with each subsequent installment being due on or before the first day of each month thereafter until the total revised penalty of \$291,722.00 is paid in full. If the first day of the month falls on a weekend or a holiday, the due date will be the next business day. A ten day grace period shall be allowed for receipt of each installment. In the event that Respondent defaults on this settlement by failing to make timely payment of a monthly installment, the entire outstanding balance of the revised penalty of \$291,722.00 shall become immediately due.
