Federal-to-local match ratio is 90:10. Approximately \$5,000 of the match will be contributed by the Tribe in the form of safety equipment, personal flotation devices, fuel and oil. Approximately \$2,900 of the match will be contributed by the Tribe covering the cost of shipping the boat from Ketchikan, Alaska to the village of Hydaburg. The remaining \$13,000 of the match will be a cash contribution from the Tribe's Transportation Department reserve funds. The vessel estimated useful life is 25 years.
