Section 5311 Projects

The FFY 2019/2020 Section 5311 program will provide: technical, operating and capital grants to support transit and intercity bus operations in New York State for fifty-two Section 5311 sub-recipients; support for RTAP; and support for project administration. All sub-recipient projects are Category A and ready to advance upon grant award.

Additionally, this grant includes \$6,676,022 for an operating assistance and a capital project (\$3,338,011 each) under the provisions of the Emergency Relief Program. The Emergency Relief (ER) Program funding uses a portion of the 2020 appropriation to support continued rural service operations in New York State, or to provide critical support for eligible capital expenditures directly related to COVID-19 as necessary. This funding is Category B until actual CARES Act funding is disbursed.

State Program Administration:

This grant includes \$4,737,723 in funding for NYSDOT salaries/fringe and technical assistance/oversight provided by a consultant as follows:

FY 2019: 10 percent of \$23,503,142: (\$2,350,314) FY 2020: 10 percent of \$23,874,088: (\$2,387,409)

Intercity Bus Operations Support:

NYSDOT continues to support Intercity Bus operations in excess of the required 15 percent of the FY 2019 and FY 2020 Section 5311 allocations as follows:

FY 2019: This grant includes \$3,728,418 for Intercity Bus projects, exceeding the 15 percent requirement that \$3,525,471 of the \$23,503,142 be used for this purpose.

FY 2020: This grant includes \$3,741,108 for Intercity Bus projects, exceeding the 15 percent requirement that \$3,581,113 of the \$23,874,088 be used for this purpose.

Combined, the total support for Intercity Bus Services is \$7,469,526, of which \$6,525,151 is in support of operating assistance; and \$944,375 is in support of capital projects. The combined \$7,469,526 provided in this grant is 15.76 percent of the total \$47,377,230 allocated in Section 5311 FY 2019 and 2020 program years.

ADTAP

This grant includes funding in support of ADTAP operating assistance and capital projects (mobility management) projects using FY 2018, FY 2019 and FY 2020 funding as follows:

FY 2018: This grant includes the remaining \$9,000 in unobligated funds for an operating assistance project.

FY 2019: Of the \$200,000 allocated, this grant includes \$149,202 in funding, of which \$130,154 will fund operating assistance projects; and \$19,048 will fund capital projects (mobility management) projects. The remaining \$50,798 will be transferred to SUZAs, see Grant Fund Administration, Transfers to Section 5307 Urbanized Area Accounts for details.

FY 2020: Of the \$200,000 allocated, this grant includes \$139,154 to fund operating assistance projects; and \$19, 048 to fund capital projects (mobility management) projects. The remaining \$41,798 will be transferred to SUZAs, in a future grant in 2021.

Grant performance period: January 1, 2020 through December 31, 2025.

COORDINATION: Locally Developed, Coordinated Public Transit – Human Services Transportation Plans (Coordinated Plans) were developed and approved in all rural areas. NYSDOT notified Section 5311 subrecipients that their rural service must be coordinated and included in the appropriate Coordinated Plan.

STATE MANAGEMENT PLAN: Attached in TrAMS, the April 2019 State Management Plan (SMP) was updated to include the CARES Act and the Emergency Relief Program in June 2020. Pre-Award Authority is invoked for projects in this grant as noted in each project ALI.
