#### **Application Executive Summary**

This application is to request Section 5311 ARP funds apportioned to the State of Colorado in the amount of \$19,927,119, representing 100% federal share of the total eligible amount. This includes the FFY21 ARP 5311 full apportionment of \$17,956,715, ARP RTAP full apportionment of \$104,141, and ARP 5311(f) full apportionment of \$1,866,263.

Purpose: CDOT will utilize ARP funding to prevent, prepare for, and respond to coronavirus.

Activities to be Performed: This application includes two projects:
