Per DOT / FTA FY2023 Tribal Transit Project Selections published list, Choctaw Nation of Oklahoma has been selected to receive the funds requested for one EV and the purchase of two electric vehicle charging stations is part of the pilot program that will run primarily throughout the Durant, OK area, where the CNO headquarters is located.

In 2022, the Choctaw Nation of Oklahoma (CNO), adopted the Bureau of Indian Affairs' pledge to commit to 50% electric vehicle (EV) sale shares by 2030. This pledge has been enthusiastically welcomed by CNO's various departments and plans for EV charging stations throughout the reservation and a stronger presence of EVs within the CNO fleet have been planned. The addition of an EV ADA-compliant bus within the Durant, OK region will act as a beacon of change to the public and a reminder of CNO's dedication to the environment and the future.

Award Description

Purpose

The Choctaw Nation of Oklahoma's (CNO) Tribal Transportation department has long been interested in the possibility of electric vehicles in its fleet. With the recent advances in charging technology, CNO is prepared to purchase an EV and test a public transportation pilot program. The CNO reservation covers approximately 10,992 square miles and is largely rural in nature.

The availability of charging stations between locations was previously considered to be prohibitive for an EV project. But CNO has recently applied for federal grants and made budgeted plans to install EV charging stations in strategic locations across the more populated areas of the reservation for both public and private use.

This pilot program will run primarily throughout the Durant, OK area, where the CNO headquarters is located. The route for the EV bus will predominantly include demand-response service and/or deviated routes where passengers can be picked-up during dedicated travel. There will be an easily accessible and private charging station available for the EV bus, maintenance facilities and trained mechanics in nearby Hugo, OK, and the added benefit of public exposure among tribal members and residents. There are plans to customize the EV bus in a CNO-approved, branded vinyl wrap that highlights the aspects and benefits of utilizing an electric vehicle.

Activities to be performed:

Choctaw Nation of Oklahoma will use these funds for the purchase of one Electric vehicle and two EV charger stations. Once the initial standard EV equipment is setup and the EV bus has been delivered, the demand-response route can begin and CNO will pay especial attention to the feedback received by the public, the daily workings of the EV bus, and begin a regular preventative maintenance schedule.

CNO is looking forward to the inclusion of an EV bus into its standard fleet and the opportunity to continue to grow and expand its current fleet to be more green and sustainable.

Expected outcomes:

The Durant route is one of the busiest demand-response areas in all of the reservation. Currently, the CNO headquarters houses a wellness center, childcare facilities, Tribal justice court system, a state-of-the-art medical clinic and pharmacy, and the primary Tribal government offices. On average, there are approximately 235 calls per month for service in the Durant area, and the use of an EV bus would be instrumental in assisting Tribal members.

Intended beneficiaries:

The Choctaw Nation of Oklahoma (CNO) is a federally recognized Native American Tribe that oversees a

10,922 square mile reservation in southeastern Oklahoma. The CNO reservations districts overlay 13 Oklahoma counties: Atoka, Bryan, Choctaw, Coal, Haskell, Hughes, Johnston, Latimer, LeFlore, McCurtain, Pittsburg, Pontotoc, and Pushmataha. The 13 counties in the reservation are among the poorest in the state, with poverty levels ranging from 14.4% (Pontotoc County) to 21.4% (Hughes County).

Poverty in this region disproportionately impacts the residents of the CNO, many of whom live below the poverty level and do not have access to regular and reliable transportation. CNO's Tribal Transit has been offering demand-response and deviated route service to tribal members since 2006. As the CNO reservation is so vast, regular routes are widespread and only service particular areas, dependent on the amount of CNO facilities in the area. The demand-response service has been in effect since the program's inception and has provided a lifeline for those who utilize its services on a daily, weekly, and monthly basis. This service allows passengers to schedule specific pick-up and drop-off times at various locations and/or facilities within a given region. This allows many tribal members the ability to visit regional medical offices when a personal vehicle is unavailable or unattainable.

Currently, CNO Tribal Transit operate regular and/or deviated routes and respond to approximately 1800 demand-response requests each month throughout the 13 counties of the reservation. The proposed EV will be primarily operated within the boundaries of Bryan county and the Choctaw Nation headquarters in Durant, Oklahoma home to 45,809 residents.
