This amendment is a VTRANs request as a \$0 amendment to move unspent funding in the amount of \$1, 368,443 from project #2 (Statewide Dispatch and Software Hardware) to project #1 (Operating Assistance) for VTRANS subrecipients.

VTrans received an FFY21 Section 5311 CRRSAA Apportionment of \$26,725,119. This amendment is requesting to use an additional \$13,094,497 of these unobligated apportionments for additional eligible expenses for SFY22 and SFY23 for a total amended and obligated amount of \$25,230,407 Federal with a remaining unobligated balance of \$1,494,712 Federal.

VTrans certifies that it, and its subrecipients and contractors that are providers of public transportation, have not furloughed any employees since March 27, 2020 (the enactment date of the CARES Act)

Original:

VTrans received FFY21 Section 5311 CRRSAA Apportionment of \$26,725,119. This application is requesting to use \$12,135,910 at 100% Federal for eligible expenses for SFY22. The remaining apportionment balance of \$14,589,209 will be applied to SFY23 eligible program expenses in a future grant application.

Purpose

This application utilizes CRRSAA funding to prevent, prepare for, and respond to coronavirus. This application for Section 5311 CRRSAA funds is for the Vermont Agency of Transportation, the designated recipient.
