The purpose of this award is to provide additional funding support for transportation planning activities for lowa's metropolitan planning organizations (MPOs) and regional planning affiliations (RPAs) as outlined in their respective planning work programs. Planning tasks outlined in the work programs will include activities related to the transportation planning process, such as long range transportation planning, short range transportation planning, transportation improvement program monitoring and development, general and comprehensive planning, program support and administrative items, and other various transportation study and plan activities. This grant contains \$716,069 in FY 2023 FHWA STBG funding (\$95,000 transfer to 5307, \$621,069 to 5311) that was transferred to FTA (TR401) to help supplement funding support for the transportation planning activities of one MPO and 10 RPAs in lowa. It will support work on the agencies transportation planning priorities and activities identified in their respective work programs over the next one-year period.
