The Pennsylvania Department of Transportation (PennDOT) is applying FFY 2022 Section 5311 Nonurbanized Area Formula Program funds and the FFY 2022 Section 5311(b)(3) Rural Transit Assistance Program Funds (RTAP) in the total amount of \$32,174,758 to support the Commonwealth's Section 5311 Program of Projects (POP).
