START AMENDMENT (02)

This Amendment (02) will re-obligate \$455,978 to ARPA Section 5311 Intercity Bus (scope 634-00) that was previously de-obligated in amendment (01) from ARPA Section 5311 Operating (scope 300-00). This makes the total for Intercity Bus \$2,470,000. The Program of Projects has been updated to reflect these changes.
