Application Executive Summary

Amendment 1 06/24/24

The purpose of this amendment is to de-obligate \$261,428 of Emergency Relief Funding (ER) that was not expended prior to the deadline and MoDOT requests to convert it to regular Section 5311 funding to be used for operating expenses at 50/50. Once the funds have been de-obligated and converted to regular Section 5311 funding, the lapse year will need to be extended to allow MoDOT time to get the funds put back in an amendment to grant MO-2019-024.

5311 - Emergency Relief Funds for COVID 19

This application is applying for \$500,000 of FY2019 5311 funds that were de-obligated from formula 5311 funding in grant MO-2019-024. We requested to transfer the \$500,000 from the regular 5311 to 5311 Emergency Relief funding at 100% federal participation. The Emergency Relief Funds for COVID 19 Operating expenses will cover a period that began after January 20, 2020. These funds will only be used for expenses directly related to COVID 19 Emergency relief.

Purpose of Award:

The Activities will include, but are not limited to, Transit bus Driver barriers that have been or will be installed on Cutaway buses, PPE (facemasks, gloves), enhanced cleaning and sanitizing supplies, staff wages, outside contract services, fuel, equipment, and personal protective equipment, service changes specifically related to Emergency Response.
