Application Executive Summary

This is an FFY2021 Section 5311c ARP application in the amount of \$46,199 representing 100% federal share of the total eligible amount. This application utilizes ARP funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes operating costs (salaries, fuel), essential transit services being provided to the community during COVID outbreak, administrative leave costs during the time when employees are not required to work so that the spread is minimized, maintenance costs associated with transit vehicles so that the equipment is operating effectively and finally, sanitation material to use when transporting individuals. The ARP funding opportunity can provide a wealth of support to the Pueblo of Santa Ana and its community members. This opportunity will not only provide financial support to the essential services being provided by the pueblo but will also support individual needs such as the maintaining of employment and getting to and from destinations that are otherwise hard to reach without transportation.

The Pueblo of Santa Ana agrees that if it receives federal funding from the federal management agency or through pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this grant agreement, it will provide written notification to FTA and reimburse FTA for any federal share that duplicates funding provided by FEMA, another federal agency, or an insurance company. Award Description

Purpose

The purpose of this funding for the Pueblo of Santa Ana is to provide financial support to payroll operations of the public transport program. The goal is to maintain a transit operating program within the Pueblo of Santa Ana that provides essential services in that community. Additionally, the funding will allow for financial support to operational costs that includes employee salaries that operate such vehicles, fuel and health and safety equipment that have a shelf life of no more than one year.

Activities to be performed:

Transit services will continue to be provided and employee retention will also continue to be. The transit services will allow for community members get to and from destinations via transit services as many members rely on such service with the labor and fuel costs. It also allows for employee retention and minimize the risk of job loss due to minimal financial support. The opportunity will allow for transit service to be maintained with fuel costs as such fluctuate considerably on a weekly basis. The opportunity will also allow for vehicle maintenance to be continued and accomplished efficiently for safe operating service. Sanitary equipment can be utilized on a continuous basis as well.

Expected outcomes:

If awarded, the opportunity will allow for the Pueblo of Santa Ana to meet the needs of the community and to continue a service that is essential. A safe and healthy transport of customers will also be achieved with the financial support of this opportunity by employee retention and supporting fluctuating fuel costs.

Many community members of the system have no other means of transportation and depend heavily on this service for access to healthcare, work, education, wellness, and social services programs.

Is it adjacent to a larger metropolitan of the City of Bernalillo, Rio Ranco and Albuquerque. Because of its location, the Pueblo's community can access essential services such as employment, education and other needs that benefit the community members of Santa Ana.
