Application Executive Summary

Pueblo de San Ildefonso is applying for \$20,883 FY23 5311c funds for operating. Pueblo de San Ildefonso will contract with NCRTD to continue transit services as depicted in the District's recently adopted service plan. The Pueblo de San Ildefonso is located in North Central New Mexico and borders the City of Santa Fe on the north. The Pueblo de San Ildefonso is a member of the North Central Regional Transit District. These services will provide greater opportunity for tribal and community members to access employment, medical, educational, and recreational facilities within the service area of the district. The NCRTD spends approximately \$35,000 a year to operate the San Ildefonso Tribal Route. The remainder funds come from gross receipts taxes received from 4 different counties including Santa Fe County. Pre-award authority is selected to cover operating expenses incurred prior to grant award.
