Also to cover Mescalero's expenditures for public transportation for the Roads Supervisor, Accountants and User Manager.

Activities to be performed:

The award will be utilized for operating expenditures, such as but not limited to, salaries to support public transportation, supplies, vehicle insurance, repairs and more. The formula funding will financially assist the roads funding that is currently being used to pay the subsidy to the local transportation provider. Public transportation for the Mescalero Apache Tribe is provided Monday through Saturday from 6:00am to 7: 30pm, except on holidays.

Expected outcomes:

It will reduce what wil come out of the (638) "Roads Fund" for the subsidy that pays for public transportation, this will enable the roads fund to be utilized for the infustructure and roads on the reservation.

Intended beneficiaries:

This will financially benefit the Mescalero Apache Tribe as a whole. Public Transportation is an essential service for the tribal members. The service enables tribal members to get to work, medical appointments, grocery shopping, transportaion to secondary education and much more.

Project Description

The Formulary Funding will be used on operating and administrative expenditures that include but not limited to, salaries, benefits, fuel, oil, vehicle maintenance/insurance and supplies.

Project Benefits

The formula funding of \$58,995 will help Mescalero Apache Tribe subsidize the public transportation service being provided by the local transportation provider, Zia Therapy Center (Ztrans) in Otero County, NM. This funding will reduce what the tribe pays through the (638) roads funds that subsidize public transportation for MAT.

Additional Information

With public transportation tribal members can access transportation from Ztrans to other systems statewide, which creates a seamless system. For tribal members who cannot drive, or because of the income limitations cannot afford to drive, public transportation gives them the opportunity to utilize an affordable, safe and reliable mode.

The Mescalero Apache is located in a mountainous area within the Otero and Lincoln counties. The Reservation encompasses 719 square miles, with approximately 463,000 acres. According to the US Census the population is approximately 4,005, the Mescalero Apache Tribe has a large population of military personnel who served in the Vietnam War. The economy of Mescalero, NM employs approximately 470 people, with industries including Accommodation & Food Services, Care & Social Assistance, Arts & Entertainment and Education services. The median household income is \$31,164. The poverty rate is 31%.

Location Description

The (MAT) Mescalero Apache Tribe is located in South Central New Mexico. We are a federally recongnized Tribe, known as the "Mescalero Apache Tribe of the Mescalero Apache Reservation". The 714 square miles of the reservation is almost entirely in Otero County but also has an unpopulated section in Lincoln County. The reservation lies on the Eastern flank of the Sacramento Mountains and boarders the Lincoln National Forest. A major highway (US 70) runs through the reservation.
