The Mi' Kmaq Nation (ABM) is requesting an additional \$37,914 in Tribal Transit formula funding. This will support the tribes existing contract for operations and maintenance.

The ABM pinned their FY24 certifications and assurances on 9/5/2024. ABM will apply indirect Costs and approval is attached. The period of performance will support FY24-25 operating activities through September 30, 2025. Tribal entities are not subject to FTA planning requirements, and the FTA will not require tribes to attach tribal transportation plans to a STIP (Statewide Transportation Improvement Program). Local share requirement the FTA does not require a non-federal matching share for Tribal Transit Program grants. Federal labor protections because direct grants from the FTA to tribes do not involve a state-recipient relationship, the labor protective provisions of 49 U.S.C. 5333 (b) do not apply to this program.

#### \*\*\*Original Grant \*\*\*

The Aroostook Micmac Tribal Government was awarded an FFY2013 Tribal Discretionary Grant (ME-18-X057-00) that provided funding to contract a consultant in order conduct a transit planning study, Transit Development Project. That study's results (attached) yielded a path forward for the Tribe to enroll in FTA's NTD reporting program and start receiving regular formula funding. This grant is the result of that the study and thus will request 5311 Tribal Transportation formula funding from:

-FFY19: \$15,229 -FFY20: \$30,349 -FFY21: \$14,546 Total: \$60,124
