Application Executive Summary

Amendment 2 - 08/28/24

This amendment is to request the recently deobligated FY20 5311 Emergency Relief funds that have been converted to 5311 Formula funding in the amount of \$300,000. MoDOT requests to use these funds for State Admin expenses to cover the cost of administering the program. By adding these funds to State Admin., MoDOT will still not exceed the 10% limit allowed for this activity (Amend 2 \$300,000 + Orig Grant \$726,936 = \$1,026,936 (5.05%) of \$20,307,703.00 apportionment).

Pre-award authority is not being used for this amendment.

Amendment 1 06/24/24

The purpose of this amendment is to de-obligate \$300,000 of Emergency Relief Funding (ER) that was not expended prior to the deadline and MoDOT requests to convert it to regular Section 5311 funding to be used for State Administration. Once the funds have been de-obligated and converted to regular Section 5311 funding, the lapse year will need to be extended to allow MoDOT time to get the funds put back in another amendment to this grant.

2-9-2021 - The source of the funds for this grant is Section 5311 funding for FFY 2020 Apportionment Allocations Notice for 5311 - \$20,307,703.00 for FY20 5311 funds , \$300,000 of FY20 5311 Emergency Relief funds and \$320,916 of FY20 RTAP funds for a total of \$20,928,619.00. These funds were taken from the Full Year Apportionment table post on 12-20-2019 for the full 12 months. The project start date is July 1, 2020 with all funds expected to be expended by December 31, 2025. This grant is for RTAP, State administration, operating, and capital assistance for 22 Missouri agencies: 11 cities, 1 county transit authority, 8 county-wide not-for-profit agencies, 2 regional not-for-profit agencies, and Section 5311(f) funds for five intercity bus carriers (three private/for-profit and two not-for-profit).

MoDOT receives an annual 5311 formula funding apportionment to support public transit throughout the state. Of the FY 2020 apportionment, MoDOT is using \$300,000 to support subrecipient capital and operating assistance activities associated with the COVID-19 pandemic response.

Under FTA's Emergency Relief Program, activities in this project support rural transit agency efforts to prevent, prepare for and respond to the COVID-19 emergency at the 100% federal funding level. Funds in this project will support COVID-19 emergency related capital and operating activities. Project Description

- 5311 State administration funds are used for 1) the services of a full-time program manager and consultant services contractor RTAP trainer, 2) training and travel for administrative employees of the transit systems as RTAP funds are used only for driver training purposes, 3) funding planning grants for feasibility studies, 4) studies done by consultants - the Statewide Intercity Bus Study, 4) assisting grantees with promoting awareness of public transit in their service area, and 5) assisting grantees with the financial burden of collection site audits for the Substance Abuse Program. 6) Consultant services contractor to preform compliance site visits and review civil rights programs.
- Section 5311(f) state administration funds are used for 1) monitoring the operations of the for-profit providers, 2) inventory control (including trips out-of-state for inventory purposes), 3) training for administrative staff, 4) driver training using a simulator, 5) marketing/promotion of routes and services, and

6) assisting with vehicle purchases by reviewing bid specs and procurement documentation.

3. Capital and operating funding for six intercity bus providers includes \$2,979,467 in operating funds, and \$108,000 in Administrative expense @ 80%. This fully allocates the required 15 percent minimum. As part of the required consultation process, the known providers in the State were notified of the availability of funds. Six systems submitted applications for funding. Six intercity bus operators will receive operating subsidies: Burlington Trailways, Greyhound Lines, Jefferson Lines, and Southeast Missouri Transportation Service, Inc. OATS Inc. and Village Tours. Burlington Trailways operates a north/south route on the east side of the state. Jefferson Lines has two north/south routes on the western side of the state. Greyhound is operating a new route St. Louis to Columbia on I-70, Columbia to Jefferson City on Hwy 63 and the west on HWY 50 to Kansas City and back, SMTS has taken over the service and vehicles and provides transportation from the Farmington/Park Hills/Potosi area to the St. Louis airport and Greyhound bus station. OATS will be operating routes several routes in the Mid MO, Midwest, Northeast, and Southwest regions of Missouri, Village Tours operates from Joplin to Wichita KS. As the 15 percent requirement has been met, no certification from the Governor is required at this time. MoDOT received funding requests exceeding the funds available. The State Management Plan is being followed; operating funds are allocated first; then capital funds.

4. RTAP - This program is offered statewide. We have contracted with Missouri University of Science and Technology for training courses which include defensive driving, first aid, and proper use of wheelchair restraints. These funds have also been used to secure the services of a driver simulator owned and operated by the Paducah Transit Authority

5. Operating funds will be used to subsidize daily operations. Some of the operating expense for the Section 5311 subrecipients is eligible to be reimbursed at 80%. These funds are considered Project Administration, rather than Operating. Expenses eligible to be reimbursed at the 80% level include insurance (other than health), physicals for drivers and background checks for new and current employees, and substance abuse testing. The POP shows the amount allocated to Project Administration in Column E for subrecipients in Category A. The 80% funding will reduce the amount shown in Column F for these systems. Local match will be derived from donations from individuals, state-county-local governments, and charitable agencies such as United Way. In addition, many not-for-profit grantees have contracts to provide service to sheltered workshops, independent living centers, nursing homes, etc. The profits from these contracts are used as match for the Section 5311 funds. The intercity bus providers use profits from other routes or package delivery as their local match.
