Application Executive Summary

Application Executive Summary

This grant application obligates a total of \$3,815,940 in Rural Technical Assistance Program and State Administration funds for Federal Fiscal Years 2022, 2023. Tennessee DOT reserved 5% of the FFY2022 Section 5311 Apportionment for State Administration, and 5% of the apportionments in FFY2023. TDOT expects to amend this grant to obligate 5% of the apportionment in FFY2024 upon completion of the intercity bus assessment. For Fiscal Years 2022 and 2023, Tennessee operated under a Governor's Certification (attached as an application document) certifying that intercity bus needs were met by rural providers and TDOT did not need to use 15% of 5311 funds on the 5311(f) program.

Upon submission of this grant for initial FTA Review, it was discovered that the 5% State Administration set aside by TDOT from FFY2022 was instead obligated into grant TN-2023-046. TDOT confirms understanding that any references to FFY2022 funds in this grant, executive summary, and Program of Projects will be fulfilled by FTA with FFY2023 funds when this grant is obligated.

Upon submission of this grant for initial FTA Review, it was discovered that remaining RTAP from FFY2023 was not obligated for subrecipient use in TN-2023-046. That grant was obligated with part of the remaining FFY2022 RTAP funding. Therefore, this grant will obligate the remaining balance of RTAP from FFY2023 in the total of \$449,388.
