Application Executive Summary

AMENDMENT #1

The Illinois Department of Transportation (IDOT) is decreasing FFY 2021 Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) Section 5311 operating funds in Scope 300-00 (ALI 30.09.08) by \$3,096,757 and adding it to various capital projects under scope 600-00 in Project 5 of this grant application. The period of performance is from 3/1/2020 through 3/30/2029.

IDOT certifies that it and any subrecipient or contractor that is a provider of public transportation: (a) are currently not furloughing any employees; (b) have to maximum extent possible, brought back any employees previously furloughed as a direct result of financial challenges caused by the COVID-19 public health emergency; or (c) have rehired or posted to rehire, any positions of employees who were laid off as a result of financial challenges caused by the COVID-19 public health emergency.

*IDOT agrees that if it receives federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding this Grant Agreement, it will provide written notification to FTA and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency or an insurance company.

There is no local share requirement for these funds, as such, 100% of costs associated with this amendment will be covered by the CRRSAA funds.

ORIGINAL

This grant to the Illinois Department of Transportation (IDOT) will utilize Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) funding. IDOT will allocate 100% of its \$21,175,341.00 of CRRSAA apportionment for reimbursements of eligible operating expenses to sub-recipients responding to the COVID-19 pandemic, and to meet its Intercity Bus set aside requirement. Projects under this grant include rural sub-recipient operating and ICB operating costs for the performance period of 3/1/2020 through 06/30/2024. To encourage rural sub-recipients to fully use CRRSAA Act funds for their Congressional intent, IDOT will be allowing operators to bill for COVID-related expenses back to 3/1/2020. The decision to make funds under this grant available solely for operating expenses will further prioritize utilization for COVID-19 related response and hopefully make tracking and reporting more expedient. The grant is organized by general activities/ALI and split into two projects. Project One covers General Public Transportation Operating Assistance, while the second project, which is labeled P4 is for Intercity Bus Operating Assistance. Pre-Award Authority is being used for this grant. As outlined by FTA guidance for CRRSAA Act funds, a match is not required; and IDOT does not intend to make sub-awards where CRRSAA Act monies are further leveraged with local match. *The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding

under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company. IDOT's Office of Intermodal Project implementation (OIPI) is the governor's designated recipient of the Federal Transit Administration's Section 5311 formula funds for public transportation services in rural and small urban areas in Illinois. Historically, grant recipients submit annual applications for funding to the Department, but in the interest of providing funding stability, it is not a competitive process. Instead, the Department funds its approved eligible sub-recipients each year based upon the States available Section 5311 allocation. The same allocation process will be followed for the CRRSAA Act Section 5311 funding. IDOT intends to fold the CRRSAA Act funding into the CARES state contract, in part, to reduce administrative burden. *As indicated by the emergency nature of these response activities, CRRSAA Act projects are not included in Illinois' STIP. The Department has set aside 15% of its CRRSAA Act Section 5311 allocation apportionments for Intercity Bus. The performance period for this grant overlaps with IDOT's other emergency funding under IL-2020-034-00 (CARES) and 1177-2021-5 (ARP). The reason for this overlap is to sufficiently cover expenses the individual grants would be unable to achieve on their own.

Award Description

Purpose

The Illinois Department of Transportation (IDOT) is requesting to amend IL-2021-041 to allow subrecipients to complete safety, security and operational repairs and improvements to their facilities, buses and equipment. This amendment decreases the Operating ALI by \$3,096,757 and allocates these funds to the various activities identified in the newly created Project 5. Projects under this grant amendment include shop equipment, ADP hardware and software, mobile surveillance and security

equipment, fare collection equipment as well as facility and vehicle renovations. The performance period of 07/09/2021 - 03/30/2029

Activities to be performed:

shop equipment, ADP hardware and software, mobile surveillance and security equipment, fare collection equipment as well as facility and vehicle renovations.

Expected outcomes:

As a result of this amendment, rural subrecipients will be able to increase the safety and security of their facilities, improve payment systems, increase security around their facilities and on their buses and increase the life of their buses.

Intended beneficiaries:

Riders and operators are the intended beneficiaries. Providers are looking to implement dispatching and scheduling software, install security cameras, and improve access to information for the riding public. In addition, rural transit systems intend to make improvements to facilities to address leaking roofs, improve dispatching areas and increase safety and security.

Subrecipient Activities:

A total of eleven (11) rural subrecipients will have their grant contracts amended to allow for the acquisition of shop equipment, ADP hardware and software, mobile surveillance and security equipment, fare collection equipment as well as facility and vehicle renovations.

Original Description:

Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) Section 5311 Operating Assistance will be used to reimburse 43 eligible sub-recipients, with the principal intent of responding to the COVID-19 pandemic. These funds will be going to transit operators providing service in 94 of 96 Downstate Counties in Illinois. The types of expense reimbursed under this project are typically those Operating Expenses reimbursed by FTA and may include, but are not limited to the following: Operator's, dispatchers and maintenance salaries, wages and fringe benefits, building repair and maintenance expenses, fuels, leases, etc. a list of eligible recipients and a more detailed eligible expense list is included in the Extended Budget Description for this Operating Assistance project. Unique to these CRRSSA Act funds, FTA has provided additional guidance and direction for the ways in which funding can be used to cover eligible expenses specifically related to response and mitigation of COVID-19. IDOT's decision to generate separate grant awards for CRRSSA Act funding is meant to prioritize these funds for their Congressional intent. This project provides for uninterrupted delivery of existing transit services. Period of performance for work under this project is from March 1 of 2021 through September 30 of 2024. Project Benefits

The Governor of Illinois issued a disaster proclamation on March 9, 2020 to facilitate the treatment and containment of COVID-19. In the past months, the impact of this pandemic has wrought significant disruption to the public transportation sector, which resulted in response measures and ridership trends that have consequences as yet not fully known. Through their best efforts, public transportation operators have worked to mitigate risk and respond to the personal and financial fallout of the crisis. CRRSSA Act funding enacted by the federal government in December 2020 will serve as an important lifeline for these operators, especially those serving rural and small urban populations.

The Centers for Disease Control and Prevention continues to urge people to avoid close contact and stay at home as much as possible. Additionally, a sizable portion of those utilizing transportation services

funded through 5311 are older adults and other vulnerable individuals. In many rural areas where close access to grocers, restaurants, and pharmacies is limited and geographically dispersed, persons who are isolated and have no other means of transportation, depend on access to public transit. Funds made available through CRRSSA Act Section 5311 will allow operators to make necessary fleet modifications meant to reduce potential spread of COVID-19 and increase driver/passenger safety. With lost ridership and many operators temporarily waiving fares as a safety measure, these funds will help maintain solvency and keep service as robust as possible.

The physical safety measures that CRRSSA Act Section 5311 funds will cover, not only serve to help mitigate health and safety concerns for the immediate impact of the pandemic but will also provide long-term benefits and resiliency for the future.

Original Grant:
